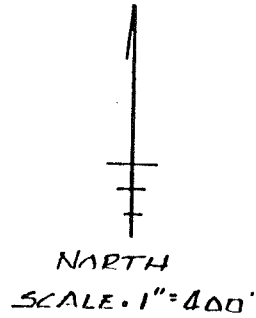

81.3 Acres Shaffer

Situated in the Township of Perry, County of Richland, State of Ohio and known as being part of the Southeast Quarter of Section 34, Township 19, Range 19, and more particularly described, as follows;

Beginning at a railroad spike set in the Northwest corner of the Southeast Quarter of Section 34 and the center of Painter Road (T.H.25);

thence South 00 deg. 11 min. East along the West of said quarter section a distance of 2676.8 feet to an iron pin set on the Southwest corner of said quarter section;

thence South 89 deg. 50 min. East along the South line of said quarter section a distance of 1318.0 feet to an iron pin set;

thence North 00 deg. 00 min. East a distance of 2680.6 feet to a railroad spike set on the North line of the Southeast Quarter of Section 34 and the center line of Painter Road (T.H.25);
