

TOWNSHIP TWENTY-TWO (22) NORTH OF RANGE NINETEEN (19) WEST IN SHARON TOWNSHIP, RICHLAND DESCRIPTION: BEING A PART OF THE NORTHWEST AND SOUTHWEST QUARTERS OF SECTION FIVE (5), NORTHWEST QUARTER OF SAID SECTION FIVE (5); OF 831.11 FEET TO AN IRON PIPE; THENCE NIº 24'E AND 483.16 FEET ARE IN THE SOUTHWEST QUARTER TO AN IRON PIPE; THENCE N88°36'W A DISTANCE SOUTHWEST QUARTER OF SECTION FIVE (5) OF WHICH A DISTANCE OF 963.10 FEET TO A COPPER ROD IN THE CENTERLINE NORTHWEST IS THE REAL POINT OF BEGINNING S6°22'W ALONG THE CENTERLINE OF S.R.-61 A DISTANCE OF 1401.92 FEET AND INTO HEREIN DESCRIBED; THENCE NIº 24'E STREET (T.H.-61); THENCE N82°53'E ALONG THE CENTERLINE OF STATE STREET FOR THE SAME AT A STONE WHICH IS THE SOUTHWEST CORNER OF THE 488.82 FEET TO A POINT WHICH IS THE REAL POINT OF BEGINNING AND CONTAINING 27.04 ACRES OF WHICH 17.62 ACRES IS IN THE THENCE A DISTANCE OF 968.76 FEET ARE IN THE NORTHWEST QUARTER 772.67 FEET TO AN IRON PIPE IN OF NORTH GAMBLE STREET (S.R.-61); ALONG THE SOUTH LINE OF SAID 읶
