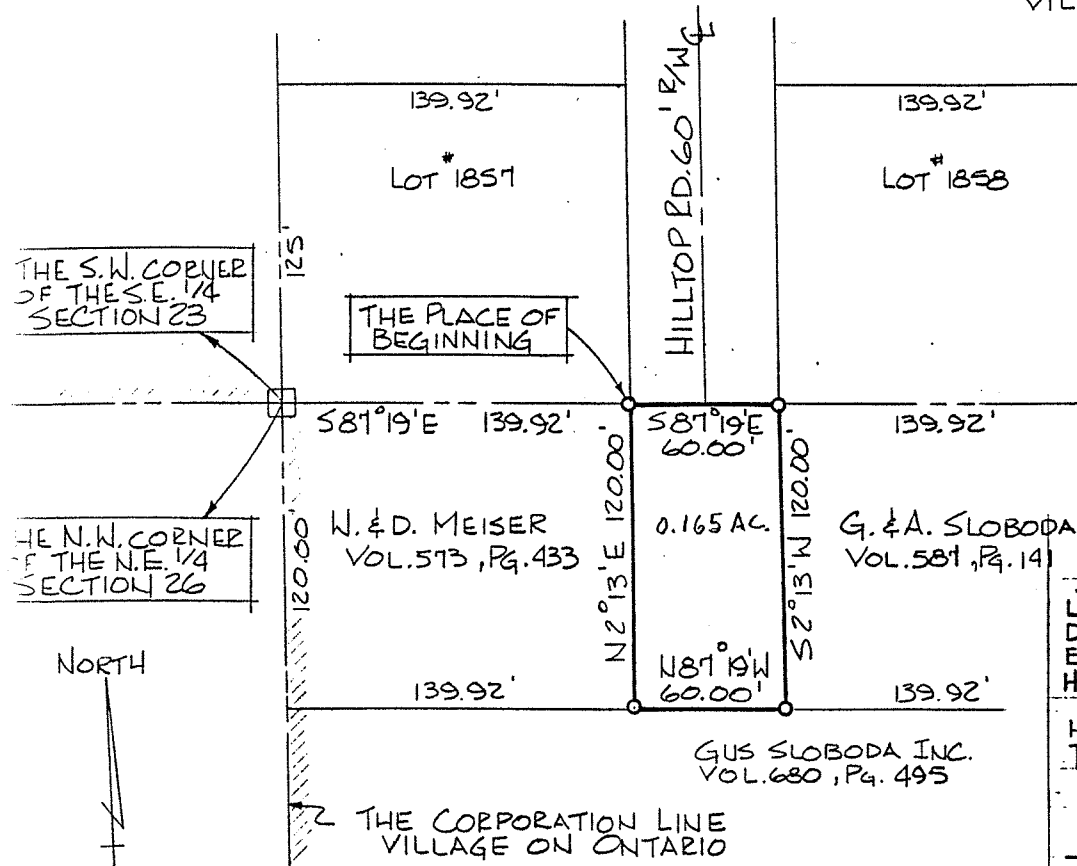

SITUATED IN THE VILLAGE OF ONTARIO, COUNTY OF RICHLAND, STATE OF OHIO AND BEING A PART OF THE NORTHEAST QUARTER OF SECTION 26, T-21 N, R-19 W, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT AN IRON PIPE (NIP) MARKING THE NORTHWEST CORNER OF SAID QUARTER, THENCE, SOUTH 87°19' EAST WITH THE NORTH LINE OF SAID QUARTER A DISTANCE OF 139.92 FEET TO AN IRON PIN SET, THE PLACE OF BEGINNING;
THENCE, SOUTH 87°19' EAST A DISTANCE OF 60.00 FEET TO AN IRON PIN SET;
THENCE, SOUTH 2°13' WEST A DISTANCE OF 120.00 FEET TO AN IRON PIN SET;
THENCE, NORTH 87°19' WEST A DISTANCE OF 60.00 FEET TO AN IRON PIN SET;
THENCE, NORTH 2°13' EAST A DISTANCE OF 120.00 FEET TO THE PLACE OF BEGINNING, CONTAINING 0.165 OF AN ACRE.
