

LEGAL DESCRIPTION
S. R. 13 at 1-71, Mansfield, Ohio
Situated in the Township of Washington, County of Richland, and State of Ohio, and known as being part of the Northeast Quarter of Section 16 and part of the Southeast Quarter of Section 9, Township 20, Range 18, and bounded and described as follows:

Beginning at the Northeast corner of the Northeast Quarter of said Section 16, being also a point in the Old Centerline of Hanley Road (C. H. 139) at its intersection with the centerline of Old S. R. 13;

Thence North 89 degrees 55 minutes West along the old centerline of Hanley Road and the Northerly line of the Northeast Quarter of Section 16, 70 feet to its intersection with the Westerly limited access line of S. R. 1 (1-71) as appropriated by the State of Ohio by perpetual easement for highway purposes as recorded in Volume 481, Page 595 of Richland County Deed Records;

Thence South 10 degrees 37 minutes 14 seconds West along the Westerly limited access line of said S. R. 1, 359.43 feet to an angle point therein;

Thence South 34 degrees 00 minutes 16 seconds West along the Northwest-only limited access line of said S. R. 1, 115.43 feet to an angle point therein;

Thence South 44 degrees 16 minutes 06 seconds West along the Northwest-only limited access line of said S. R. 1, 275.55 feet to an angle point therein;

Thence South 50 degrees 39 minutes 04 seconds West along the Northwest-only limited access line of said S. R. 1, 156.67 feet to its intersection with the Westerly line of a parcel of land owned by Phillips Petroleum Co. by deed recorded in Volume 521, Page 256 of Richland County Deed Records;

Thence North 1 degree 33 minutes West along the Westerly line of said land conveyed to Phillips Petroleum Co., 229.55 feet to its intersection with the Old Centerline of Hanley Road;

Thence South 89 degrees 55 minutes East along the Old Centerline of Hanley Road 147.66 feet to its intersection with the Westerly line

of a parcel of land formerly conveyed to Helle Harbaugh by deed recorded in Volume 433, Pages 272 and 274 of Richland County Deed Records;

Thence North 0 degrees 46 minutes West along the Westerly line of said land formerly conveyed to Helle Harbaugh, 51.95 feet to its intersection with the curved centerline of Relocated Hanley Road;

Thence Northeasterly along the curved centerline of Relocated Hanley Road, being the arc of a circular section of a spiral curve deflecting to the left, 32.15 feet to a point of curve spiral, said arc having a radius of 160 feet and a chord which bears North 61 degrees 43 minutes 34 seconds East, a distance of 32.17 feet;

Thence Northeasterly along the curved centerline of Relocated Hanley Road, being a spiral curve deflecting to the left, 200 feet to a point of spiral tangency, said spiral being the spiral of far transition of a complete transitional curve having an intersection angle between tangents of the entire curve of 42 degrees 35 minutes, a 12 degree 27 minute 20 second degree of circular curvature, a 400 foot radius of the circular curve, a 200 foot spiral curve of near transition and a 200 foot spiral curve of far transition and a tangent of the complete curve of 234.77 feet;

Thence North 47 degrees 14 minutes East along the centerline of relocated Hanley Road 30.04 feet to a point of curvature;

Thence Northeasterly along the curved centerline of Relocated Hanley Road, being the arc of a circular curve deflecting to the right, 123.94 feet to a point of tangency, said arc having a radius of 210 feet and a chord which bears North 66 degrees 14 minutes East, a distance of 150.51;

Thence North 89 degrees 14 minutes East along the centerline of Relocated Hanley Road 10.00 feet to its intersection with the centerline of Old S. R. 13;

Thence South 0 degrees 46 minutes East along the centerline of Old S. R. 13, 265.25 feet to the place of beginning, and containing 212,744 square feet or 4.8839 Acres of land according to the survey of Donald G. Bohning & Associates, Inc.
