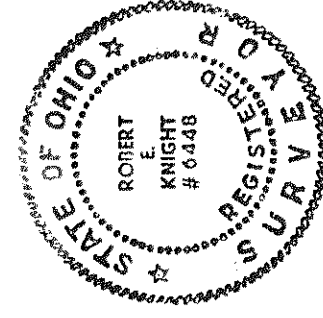

SITUATED IN THE TOWNSHIP OF WASHINGTON, COUNTY OF RICHLAND,
STATE OF OHIO, AND BEING PART OF SECTIONS 29 AND 32, TOWNSHIP
20 NORTH, RANGE 18 WEST, CONGRESS LANDS NORTH OF THE OLD SEVEN
RANGES, BEING BOUNDED AND DESCRIBED AS FOLLOWS:
BEGINNING AT A POINT FOUND AT THE INTERSECTION OF THE
CENTERLINE OF STATE ROUTE 97 (LUDOWILL LEXINGTON ROAD) WITH
THE COMMON LINE BETWEEN SECTIONS 29 AND 32;
THENCE SOUTH 30°-35'-55" EAST ALONG THE CENTERLINE OF STATE
ROUTE 97, 127.88 FEET TO A POINT THEREIN, SAID POINT BEING THE
PRINCIPAL PLACE OF BEGINNING; BEING A PARCEL OF LAND
CONTAINING 1.03776 ACRES, BE THE SAME, MORE OR LESS, BUT

BEGINNING AT A POINT FOUND AT THE INTERSECTION OF THE
CENTERLINE OF STATE ROUTE 97 (LUDOWILL LEXINGTON ROAD) WITH

THENCE NORTH 89°-11'-09" EAST A DISTANCE OF 229.83 FEET TO
A POINT;

THENCE NORTH 30°-35'-55" WEST ALONG THE CENTERLINE OF STATE
