

Legal Description Madison Township Board of Education 1.010 Acres

Situated in the Township of Madison, County of Richland, State of Ohio and being part of the southeast quarter of Section 13, Township 21-N, Range 17-W and more particularly described as follows:

Commencing at the southwest corner of the southeast quarter of said Section 13 said corner referenced by a railroad spike found 3.40 feet due east of said point; thence N 00°27'45" W, a distance of 206.88 feet along the west line of said southeast quarter also being the centerline of McElroy Road (TH-274,60' R/W) to a point referenced by a survey marker set N 89°35'45" E, at a distance of 30.00 feet, said point being the Principal Point of Beginning for the parcel described herein;

- 1) thence continuing N 00°27'45" W, a distance of 200.00 feet along said quarter section line and centerline to a point referenced by a survey marker set as described in the following course;
- 2) thence N 89°35'45" E, a distance of 220.00 feet along the south property line of land conveyed to Nancy L. Miles by O.R.V. 385, Pg. 46 to a survey marker set and passing for reference a survey marker set at 30.00 feet;
- 3) thence S 00°27'45" E, a distance of 200.00 feet along the west property line of land conveyed to Madison Township Board of Education by D.V. 421, Pg. 283 to a survey marker set;
- 4) thence S 89°35'45" W, a distance of 220.00 feet along the north property line of land conveyed to Madison Township Board of Education by D.V. 433, Pg. 144 to the Principal Point of Beginning, and passing for reference a survey maker set at 190.00 feet, enclosing an area of 1.010 acres, more or less, subject to all legal easements, use restrictions and public right of way now on record.
