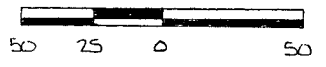
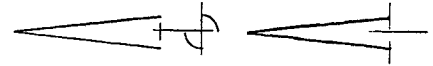

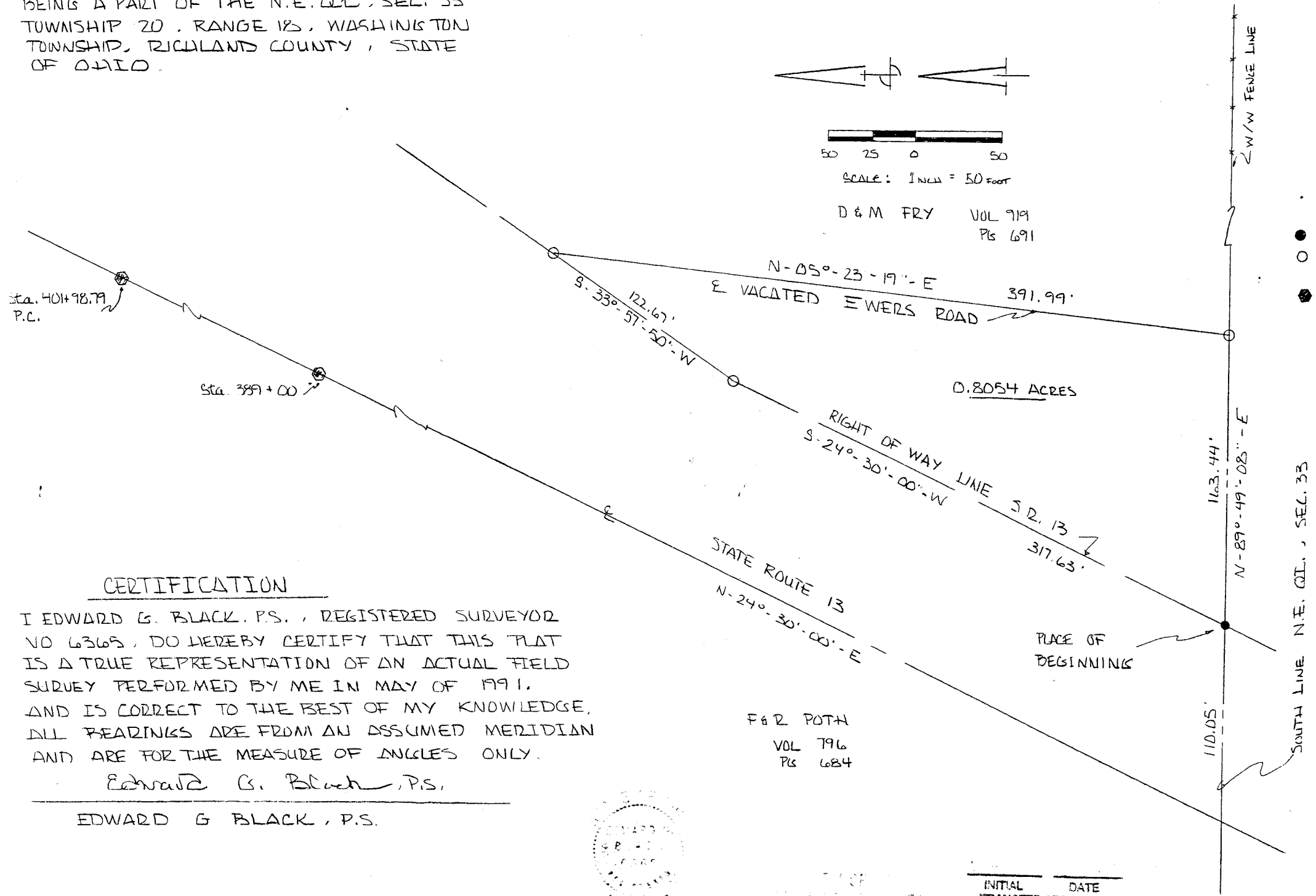

BEING A PARCEL OF LAND SITUATED IN PART OF THE NORTHEAST QUARTER OF SECTION NUMBER 33, TOWNSHIP 20 - RANGE 18, TOWNSHIP OF WASHINGTON, COUNTY OF RICHLAND, STATE OF OHIO AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT AN IRON PIN FOUND AT THE INTERSECTION OF THE SOUTH LINE OF THE NORTHEAST QUARTER OF SECTION NUMBER 33 AND THE EAST RIGHT - OF - WAY LINE OF STATE ROUTE NUMBER 13:

THENCE NORTH - 89 DEG. - 49 MIN. - 08SEC. - EAST AND ALONG SAID SOUTH LINE A DISTANCE OF ONE HUNDRED SIXTY THREE AND FOURTY FOUR HUNDREDTHS (163.44) FEET TO AN IRON PIN WITH CAP SET IN THE CENTER OF VACATED EMERS ROAD;

THENCE NORTH - 05 DEG. - 23 MIN. - 19 SEC. - EAST AND ALONG THE CENTER OF SAID VACATED ROAD A DISTANCE OF THREE HUNDRED NINETY ONE AND NINETY NINE HUNDREDTHS (391.99) FEET TO AN IRON PIN WITH CAP SET IN THE EAST RIGHT - OF - WAY LINE OF STATE ROUTE NUMBER 13;
