

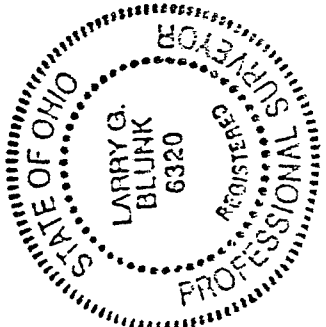
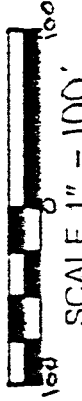
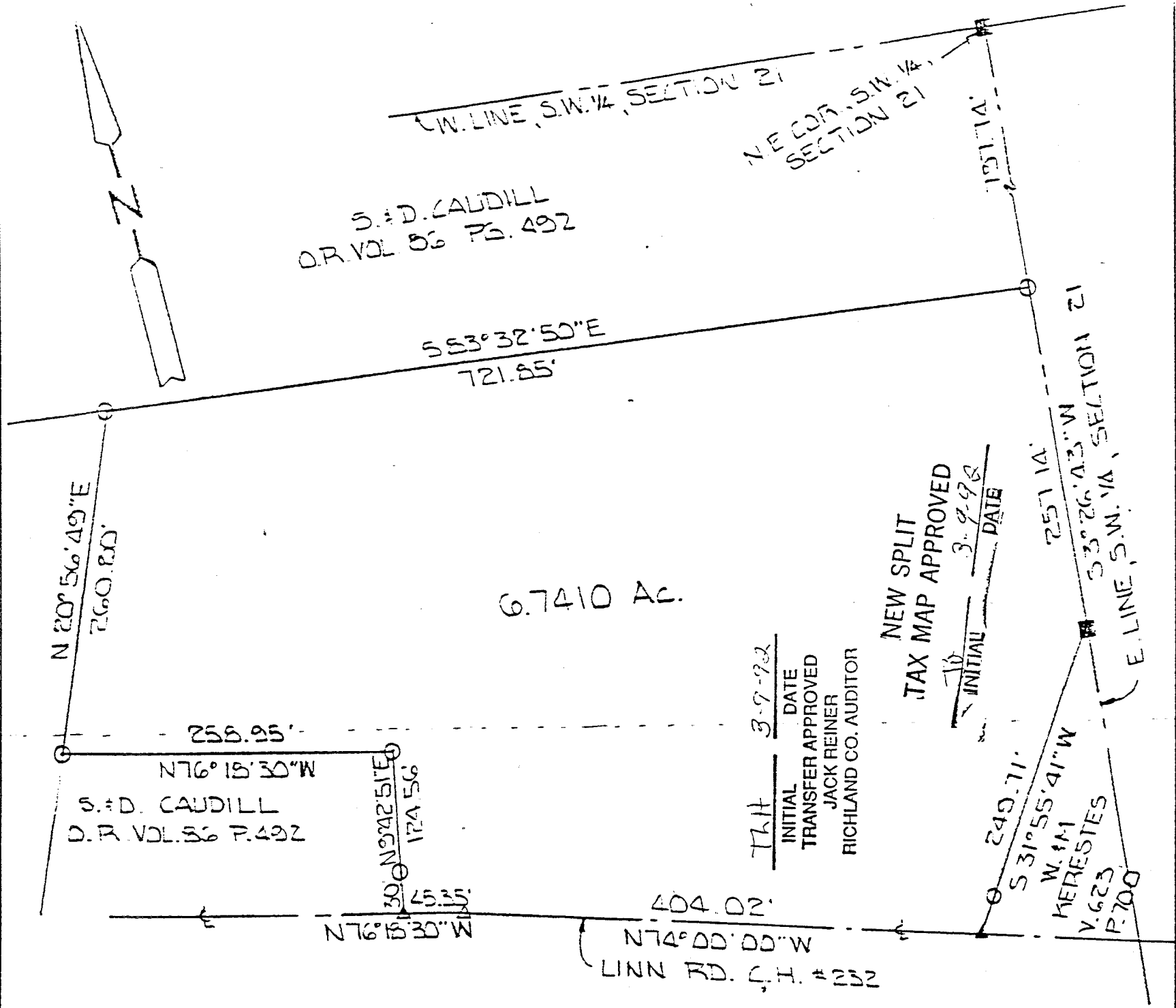
PLAT OF SURVEY FOR GUY GLOVER

DESCRIPTION
FOR
GUY GLOVER

Located in the Township of Franklin, County of Richland, State of Ohio and being a part of the Southwest Quarter of Section 21, Township 22, Range 18 and more particularly described as follows:

Beginning at a fence post found in the Northeast Corner of the Southwest Quarter of Section 21.

Thence S 03 degrees 26' 43" W along the east line of the Southwest Quarter of Section 21 a distance of 797.74 feet to an iron pin set.

Thence continuing S 03 degrees 26' 43" W along the east line of the Southwest Quarter of Section 21 a distance of 257.14 feet to a fence post found.

Thence S 31 degrees 55' 41" W passing thru an iron pin set a 219.71 feet a total distance of 249.71 feet to a p.k. nail set in the centerline of Linn Rd. C.H. 232.

Thence N 74 degrees 00' 00" W along the centerline of Linn Rd. C.H. 232 a distance of 404.02 feet to a p.k. nail set.

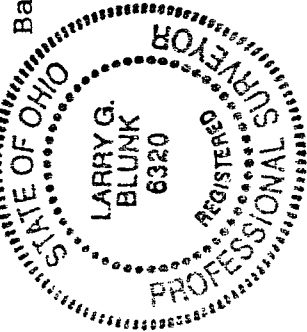
Thence N 76 degrees 18' 30" W along the centerline of Linn Rd. C.H. 232 a distance of 45.35 feet to a p.k. nail set.

Thence N 09 degrees 42' 51" E passing thru an iron pin set at 30.0 feet a total distance of 124.56 feet to an iron pin set.

Thence N 76 degrees 18' 30" W a distance of 258.95 feet to an iron pin set.

Thence N 20 degrees 56' 49" E a distance of 260.80 feet to an iron pin set.

Thence S 83 degrees 32' 50" E a distance of 721.85 feet to the True Place of Beginning and containing 6.7410 acres more or less but subject to all legal highways also all easements of record.


