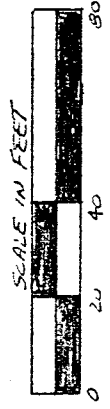

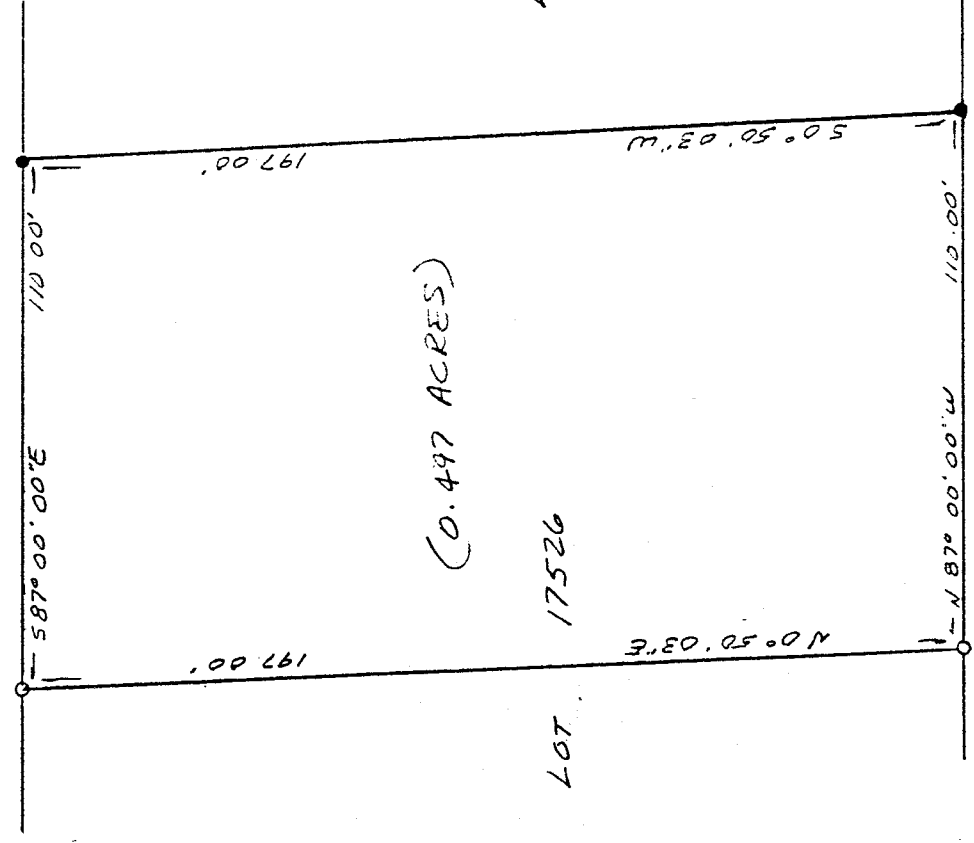

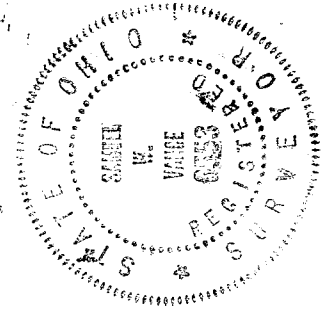

DESCRIPTION - 0.497 ACRE TRACT

Being the east 110.00 feet of Lot 17526 of the City of Mansfield, Richland County, State of Ohio and being of Record in Plat Book 21, Page 109 and being that land of record in Official Records Volume 79, Page 925 in the Richland County Recorder's Office and being more particularly described as follows;

Beginning at an iron pipe found on the south line of Betner Drive (50.00 feet wide) at the northeast corner of Lot 17526;

thence from the place of beginning South 00 degrees 50 minutes 03 seconds West along the east line of Lot 17526, the west line Lot 17525, a distance of 197.00 feet to an iron pipe found;

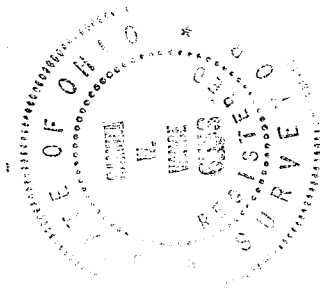
thence North 87 degrees 00 minutes 00 seconds West along the south line of Lot 17526 a distance of 110.00 feet to a 1/2 inch iron pin set;

thence North 00 degrees 50 minutes 03 seconds East across Lot 17526 a distance of 197.00 feet to a 1/2 inch iron pin set;

thence South 87 degrees 00 minutes 00 seconds East along the south line of Betner Drive, the north line of Lot 17526, a distance of 110.00 to the place of beginning - containing 0.497 acres, more or less.

Subject to all legal right-of-way of previous record.

The above description was prepared from a survey made by me, Samuel W. Vance, Registered Surveyor No. 6553 in December, 1995. Bearing basis from survey A-236. All pins set are 1/2 inch by 30 inch iron pins with plastic caps stamped Vance 6553.
