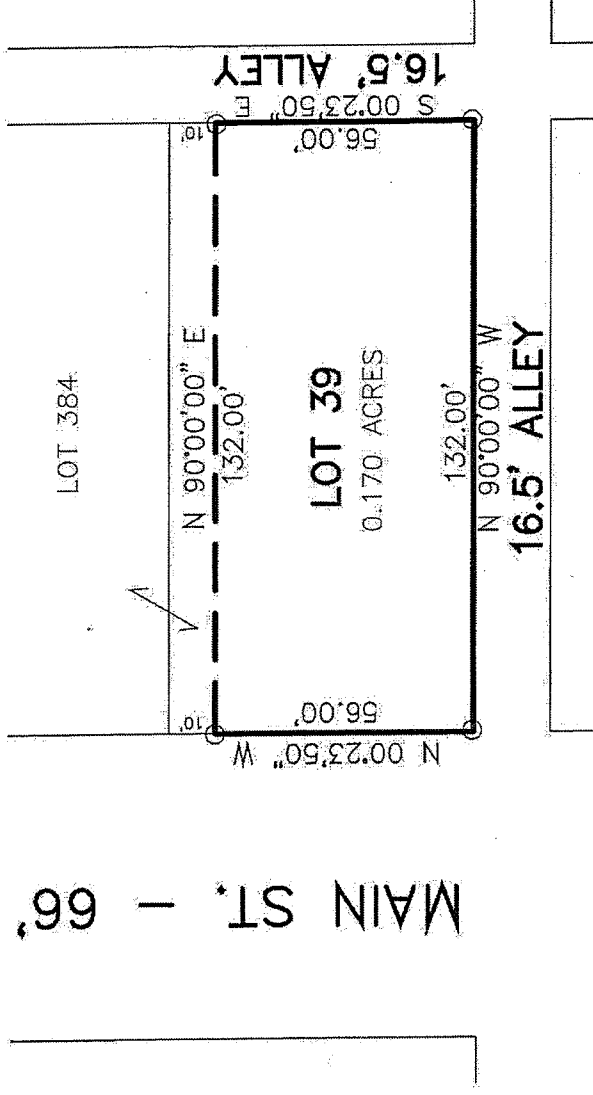
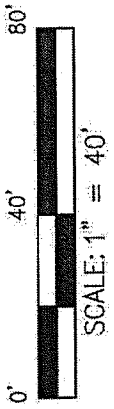
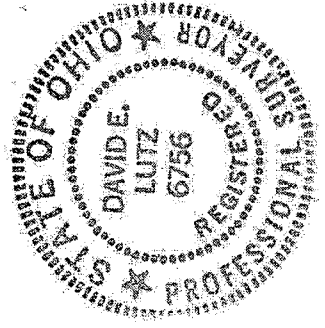


PLAT OF PROPERTY SURVEY

PART LOT 39
VILLAGE OF BELLVILLE, RICHLAND COUNTY, OHIO

DESCRIPTION: Being Part of Lot 39 in the Village of Bellville, Richland County, Ohio and being more particularly described as follows;

Beginning for the same at a iron pin found at the intersection of the east right-of-way of Main Street (66 foot in width), and the north line of a 16.5 foot alley, which iron pin is the southwest corner of Lot 39 and the real point of beginning of the parcel herein described;

- 1.) thence N 00°23'50" W a distance of 56.00 feet along the east right-of-way of Main Street to an iron pin found;
- 2.) thence N 90°00'00" E a distance of 132.00 feet, to an iron pin found on the east line of Lot 39;
- 3.) thence S 00°23'50" E a distance of 56.00 feet along said east line, to an iron pin found at the southeast corner of Lot 39;
- 4.) thence N 90°00'00" W a distance of 132.00 feet to the iron pin found at the real point of beginning;

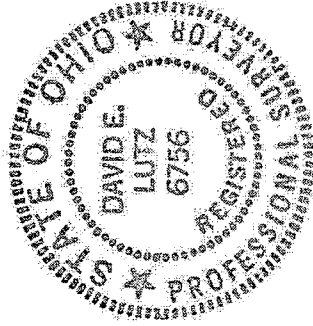
and containing 0.17 acres, more or less, but subject to all legal easements and public rights-of-way now on record. All pins set have caps stamped "LUTZ 6756".
