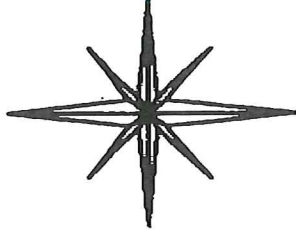


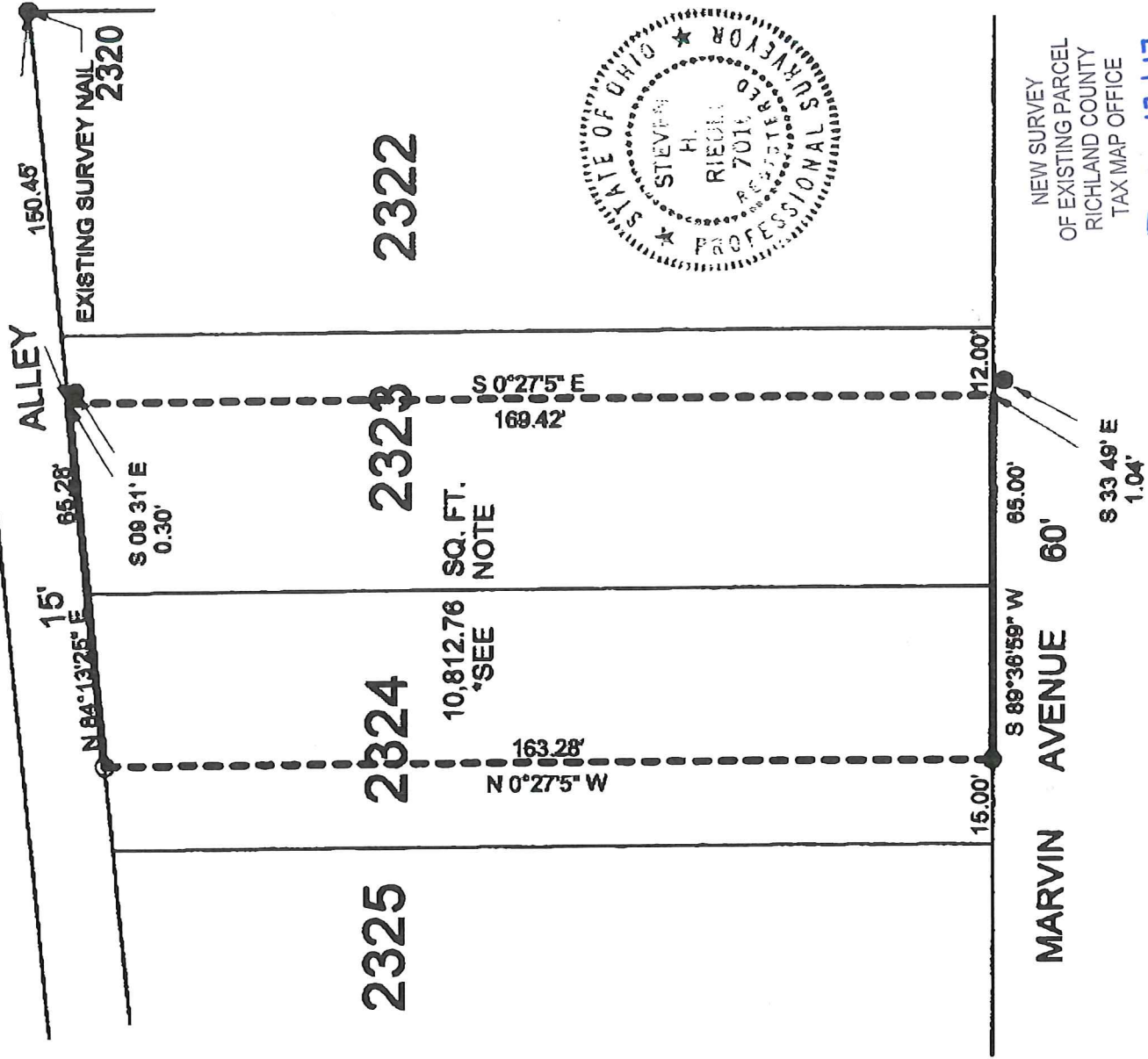

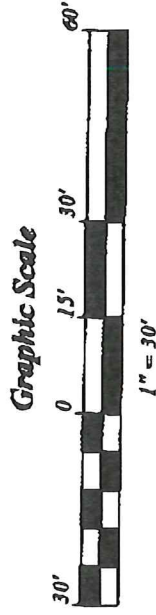

Being known as part of Inlot 2323 and part of Inlot 2324 of the new and revised numbers of the City of Shelby, County of Richland, State of Ohio and being more fully described as follows:

Commencing at an existing survey nail at the Northeast corner of Inlot 2320;

thence running South 84 deg. 13 min. 25 sec. West along the South line of an existing 15.00 foot alley for 150.45 feet to the place of beginning (an existing iron pipe being South 09 deg. 31 min. 00 sec. East and 0.31 feet from this corner);

thence turning and running South 00 deg. 27 min. 05 sec. East for 169.42 feet (an existing iron pipe being South 33 deg. 49 min. 00 sec. East and 1.04 feet from this corner, said corner being South 89 deg. 36 min. 59 sec. West and 12.00 feet from the Southeast corner of Inlot 2323);

thence turning and running South 89 deg. 36 min. 59 sec. West along the South line of Inlots 2323 and 2324 (also being the North line of Marvin Avenue) for 65.00 feet to an existing iron pipe;

thence turning and running North 00 deg. 27 min. 05 sec. West for 163.28 feet to a 5/8 inch rebar set on the North line of Inlot 2324;

thence turning and running North 84 deg. 13 min. 25 sec. East along the North line of Inlots 2324 and 2323 for 65.28 feet to the place of beginning.

All 5/8 inch rebars set have a plastic cap stamped "PS 7016".

The above described parcel has a calculated area of 10,812.76 square feet of land according to a survey made on September 11, 1997 by Steven H. Riedel, Ohio surveyor 7016.
