Thence N 90 degrees 00' 00" E a distance of 50.00 feet to an iron pin set on the east line of Lot Number 18213.

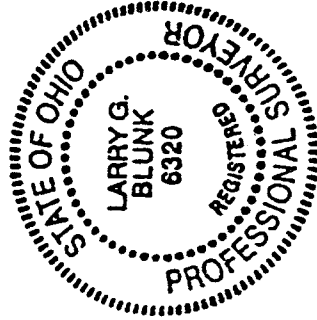

Thence S 90 degrees 00' 00" W a distance of 99.92 feet to an iron pin set on the west line of Lot Number 18214.

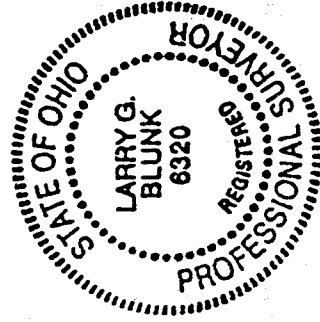
Thence N 01 degrees 22' 00" E along the west line of Lot Number 18214 a distance of 55.00 feet to an iron pin set.

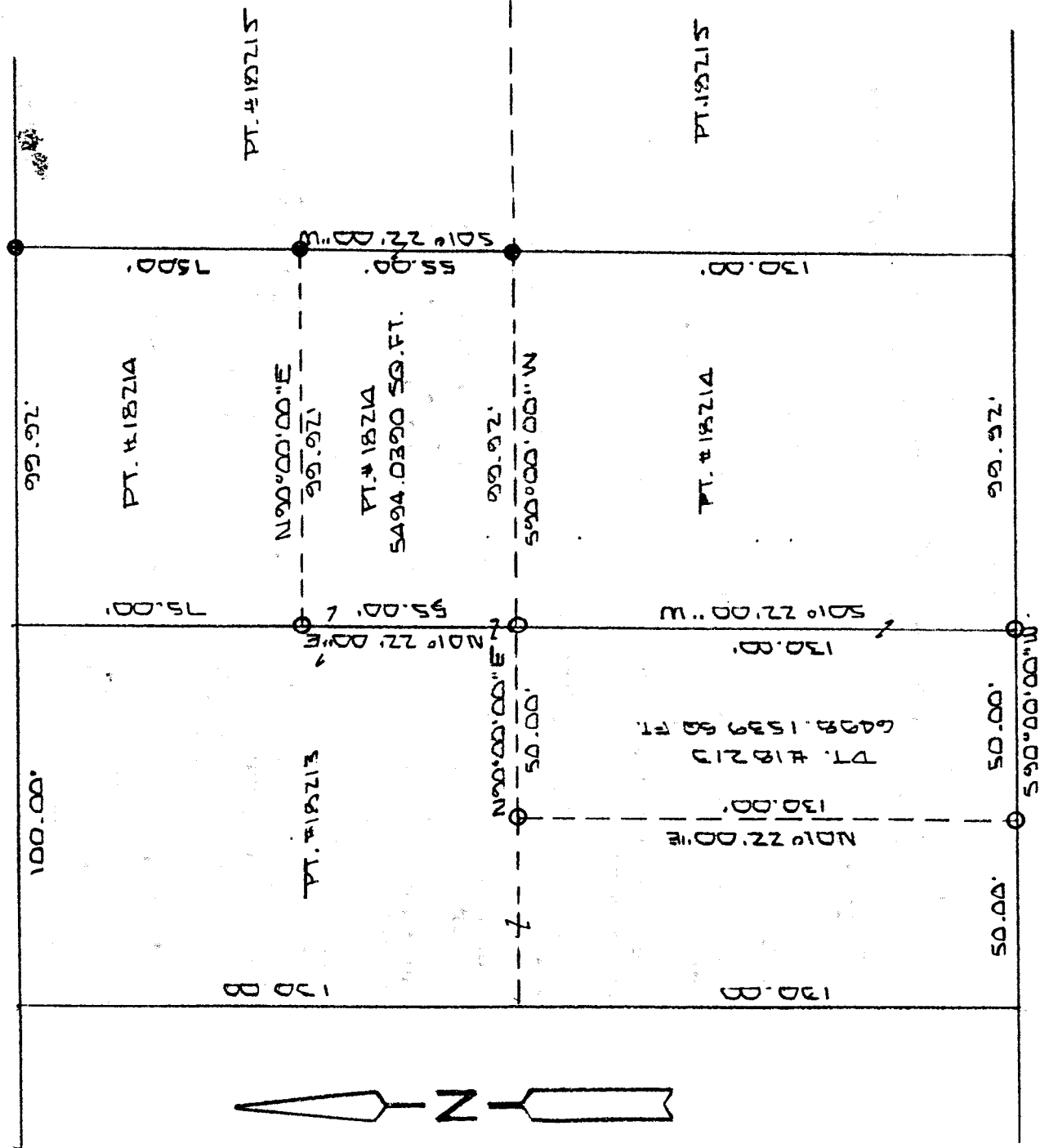

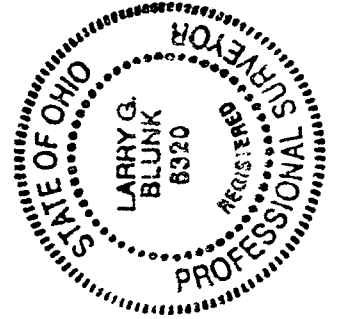
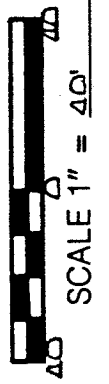
SECTION LOT # PT. LOT #18214 & PT. LOT #18213 N.16 P. 18
