LEGAL DESCRIPTION

March 26, 2022

Situated in the Township of Cass, County of Richland, State of Ohio and being a part of the Southeast Quarter of Section 11, a part of the Southwest Quarter of Section 12, Township 23 North, Range-19 West, and being a portion of the lands conveyed to Stephen N. Jr. and Dorothy Newswanger by official record volume 2833, page 183 of the Richland County Recorder's records and being more particularly described as follows:

Commencing at a stone found and accepted as marking the northeast corner of said Southeast Quarter, said stone also marking the northwest corner of a parcel conveyed to Charles R. & Marilyn Pennell by official record volume 2965, page 538 and Richard L. and Barbara J. Adams, trustee by official record volume 2950, page 515;

Thence South 01 degree 32 minutes 41 seconds East, 1590.32 feet along the east line of said Southeast Quarter, the west line of said Pennell & Adams' parcel to an iron pin set marking the **Place of Beginning** of the parcel herein described;

Thence, the following TEN courses:

- 1. **South 01 degree 32 minutes 41 seconds East, 227.72 feet** continuing along the east line of said Southeast Quarter and the west line of said Pennell & Adams' parcel to an iron pipe found in the southwest corner of said Pennell & Adams' parcel;
- 2. **North 88 degrees 56 minutes 24 seconds East, 210.00 feet** along the south line of said Pennell & Adams' parcel to an iron pin found in the northwest corner of a parcel in the name of Stephen Z. and Mabel Z. Newswanger by official record volume 1642, page 859;
- 3. South 01 degree 32 minutes 45 seconds East, 457.33 feet along a west line of said Stephen Z. Newswanger parcel to an iron pin found in a westerly corner thereof;
- 4. **South 31 degrees 58 minutes 49 seconds East, 237.77 feet** along a southwesterly line of said Stephen Z. Newswanger parcel to an iron pin found in an interior corner thereof;
- 5. **South 01 degree 32 minutes 41 seconds East, 92.97 feet** along a west line of said Stephen Z. Newswanger parcel to a point on the centerline of State Route 603-(60' R/W), and passing through an iron pin found for reference at 52.97 feet;

- 6. North 51 degrees 29 minutes 20 seconds West, 666.96 feet along the centerline of State Route 603 to a point of curvature, said point being referenced by a concrete R/W monument found North 38 degrees 30 minutes 40 seconds East, 30.00 feet therefrom;
- 7. Along a curve to the right with a radius of 2022.20 feet, with an arc length of 253.16 feet, with a delta angle of 07 degrees 10 minutes 22 seconds, a chord bearing North 47 degrees 54 minutes 09 seconds West, and a chord length of 252.99 feet continuing along said centerline of State Route 603 to a Magnail spike found marking a point of tangency;
- 8. North 44 degrees 18 minutes 58 seconds West, 108.85 feet continuing along said centerline of State Route 603 to a 2" Magnail spike set;
- 9. **North 45 degrees 41 minute 02 seconds East, 443.37 feet** traversing aforementioned Stephen N. Jr. and Dorothy Newswanger parcel to an iron pin set, passing through an iron pin set for reference at 30.00 feet;
- 10. North 88 degrees 27 minutes 19 seconds East, 111.59 feet traversing said Stephen N. Newswanger parcel to the Place of Beginning, containing a total of 7.1790 acres, of which, 4.0468 acres are located in said Southeast Quarter of Section 11, and 3.1322 acres are located in said Southwest Quarter of Section 12, and subject to all legal highways and easements, leases, and use restrictions of record.

Bearings are to an assumed meridian and are used to express angles only.

Iron pins set are 5/8" rebar with plastic cap stamped "Ramsey S-8396".
