

Description 20.723 acre parcel

Being a part of the northwest quarter of Section 35, Washington Township, T-20 N, R-18 W, Richland County, Ohio, also known as all of the lands conveyed to Blessing Acre Farms, LLC in Official Record vol. 2980 page 156, PN 0523601813005.

Described as follows:

Beginning at a 1/2 inch rebar found marking the southeast corner of the northwest quarter of Section 35 the TRUE POINT OF BEGINNING.

thence with the following SIX (6) COURSES:

- 1) S 89 degrees 30' 51" W 450.28 feet along the quarter section line to a 1/2 inch rebar found:
- 2) N 00 degrees 01' 22" W 1965.83 feet along Preston J. Bradford, Trustee of the J Bradford Trust's (O.R. 1740 page 786) east line to a point in the center of Alexander Road aka T.H. 340, witnessed by a 1/2 inch rebar found S 00 degrees 01' 22" E 30.00 feet;
- 3) N 73 degrees 19' 57" E 334.71 feet along the centerline of Alexander Road aka T.H. 340 to a point, witnessed by a 1/2 inch rebar found N 71 degrees 31' 53" E 130.80
- 4) Along a curve to the left having a delta angle of 26 degrees 24' 55", R 313.83 feet, T – 73.65 feet, Ch. Brg. – N 60 degrees 07' 29" E, Ch. – 143.41 feet along the centerline of Alexander Road aka T.H. 340 an arc distance of 144.69 feet to a point, witnessed by a 1/2 inch rebar found S 00 degrees 33' 08" W 30.00 feet;
- 5) S 00 degrees 33' 08" W 599.72 feet along Roger L. Sutherland and Rebecca J. Sutherland's (O.R. 2540 page 25) west line to a stone found;
- 6) S 00 degrees 26' 35" E 1529.80 feet along Michael L. Chambers and Carol W. Chambers' (O.R. 1473 page 709) west line to the TRUE POINT OF BEGINNING.
