Situated in the Township of Bloominggrove, County of Richland, State of Ohio and being a part of the Northeast quarter of Section 7, Township 23 North, Range 18 West, and being more particularly described as follows:

Beginning for the same at a mag nail spike found and accepted as marking the northwest corner of said quarter and being in the centerline of Noble Road (C.H. 81), said mag being referenced by an iron pin set on a bearing of South 01 degree 45 minutes 21 seconds East and at a distance of 25.00 feet, Thence, North 89 degrees 20 minutes 24 seconds East with the north line of said quarter and with said centerline 637.97 feet to a point referenced by an iron pin set on a bearing of South 01 degree 45 minutes 21 seconds East and at a distance of 25.00 feet:

Thence, South 01 degree 45 minutes 21 seconds East passing through said iron pin set, and passing through an iron pin set at a distance of 1977.58 feet, a total distance of 2730.23 feet to an iron pin set on the south line of said quarter section;

Thence, South 89 degrees 05 minutes 12 seconds West with the south line of said quarter section 637.93 feet to an iron pin set marking the southwest corner of said quarter section;

Thence, North 01 degrees 45 minutes 21 seconds West with the west line of said quarter section and passing through an iron pin set at a distance of 2708.06 feet, a total distance of 2733.06 feet to the place of beginning, containing a total of 40.00 acres, according to a survey by Chad F. Craig P.S. #8195 for Seiler & Craig Surveying, Inc. on April 5, 2022, but subject to all easements, right of ways and highways of record.

Thence, South 69 degrees 52 minutes 36 seconds East 334.69 feet to an iron pin set;


Thence, South 01 degree 45 minutes 21 seconds East 1798.76 feet to an iron pin set;
