## **LEGAL DESCRIPTION**

April 7, 2022

**Situated** in the Township of Jackson, County of Richland, State of Ohio, and being a part of the Southeast Quarter of Section 15, Township 22-North, Range 19-West and being lands conveyed to Berlyn and Onedra Esbenshade by official record volume 2626, page 235 of the Richland County Recorder's records and being more particularly described as follows:

**Commencing** at an iron pipe found and accepted as marking the southwest corner of said Quarter said iron pin also being on the centerline of Taylortown Road-(C.R. 200)(60' R/W);

Thence, **North 89 degrees 24 minutes 16 seconds East, 888.27 feet** along said centerline of Taylortown Road, the South line of said Quarter, to a point in the southeast corner of a parcel conveyed to Andrew J. Sloan by official record volume 2722, page 223, said point being the **Place of Beginning** of the parcel herein described, referenced by an iron pipe found South 05 degrees 14 minutes 45 seconds East, 0.29 feet therefrom;

Thence, the following FOUR courses:

- 1. North 05 degrees 14 minutes 45 seconds West, 266.20 feet along the east line of said Sloan parcel to a point in the northeast corner thereof, said point being on a south line of a parcel conveyed to Steven L. and Nancy K. Stover by official record volume 2389, page 395, referenced by an iron bar found North 05 degrees 14 minutes 45 seconds West, 0.66 feet therefrom, passing through an iron bar found for reference at 29.78 feet;
- 2. **North 89 degrees 24 minutes 16 seconds East, 100.72 feet** along the south line of said Stover parcel to an iron pin found in the northwest corner of a parcel conveyed to Douglas A. Spangler by official record volume 2559, page 37;
- 3. **South 05 degrees 20 minutes 15 seconds East, 266.24 feet** along the west line of said Spangler parcel to a point in the southwest corner thereof, said point being on the aforementioned south line of said Quarter, the same also being the aforementioned centerline of Taylortown Road, and passing through an iron pipe found for reference at 236.24 feet;
- 4. **South 89 degrees 24 minutes 16 seconds West, 101.15 feet** along said south line and said centerline to the **Place of Beginning**, containing 0.6148 of an acre (26,780.47 square feet), more or less, and subject to all legal highways, easements, leases, and use restrictions of record.

Bearings are to an assumed meridian and are used to express angles only.
