

SURVEYOR'S DESCRIPTION FOR MARCUS & REBEKAH BURKHOLDER

7.902 Acres

Situated in the Township of Cass, County of Richland, State of Ohio, being part of the Southwest Quarter of Section 12, also being part of the Northwest Quarter of Section 13 and the Northeast Quarter of Section 14, Township 23, Range 19 and being more particularly described as follows:

Beginning at an iron pin found in the southwest corner of said Southwest Quarter of Section 12, said iron pin also being in the northwest corner of said Northwest Quarter of Section 13 and begin in the northeast corner of said Northeast Quarter of Section 14;

Thence with following **TEN** courses:

- 1) S 88° 19' 24" E, 349.52 feet along the south line of said Southwest Quarter of Section 12, also being along the north line of said Northwest Quarter of Section 13 to an iron pin found in a southeast corner of a parcel of land conveyed to Stephen Z. and Mable Z. Newswanger by official records volume 1642, page 859;
- 2) N 04° 43' 28" E, 56.02 feet to a point being a northeasterly corner of said land, said point also being in the centerline of S.R. 603 (60') and being referenced by an iron pin found S 04° 43' 28" W, 56.02 feet from said point;
- 3) S 48° 50' 30" E, 54.89 feet along said centerline of S.R. 603 (60') to a point being the northwesterly corner of a parcel of land conveyed to Mex Properties LLC by official records volume 2936, page 89, said point being referenced by an iron pin found S 14° 51' 59" W, 39.03 feet from said point;
- 4) S 14° 51' 59" W, 588.93 feet along the westerly line of said land of Mes Properties LLC to an iron pin found in the southwesterly corner of said land, said iron pin also being in the northerly corner of a parcel of land conveyed to Michael D. Rietschlin by deed volume 803, page 416 and passing through previously referenced iron pin found at 39.03 feet;
- 5) S 54° 41' 02" W, 140.76 feet along the northwesterly line of said land of Michael D. Rietschlin to an iron pin found:
- 6) S 76° 11' 12" W, 209.38 feet and continuing along said northwesterly line of said land of Michael D. Rietschlin to an iron pin found in an interior corner of said land;
- 7) N 63° 27' 16" W, 269.06 feet along the northeasterly line of said land of Michael D. Rietschlin to an iron pin found in an interior corner of said land;
- 8) N 14° 51' 06" E, 533.15 feet along the easterly line of said land of Michael D. Rietschlin to an iron pin found in an interior corner of said land;
- 9) S 88° 24' 20" E, 175.38 feet along a south line of said land of Michael D. Rietschlin to an iron pin found in a southeast corner of said land, said iron pin also being in the west line of said Northwest Quarter of Section 13 and being in the east line of said Northeast Quarter of Section 14;
- N 02° 33' 32" E, 60.46 feet along an east line of said land of Michael D. Rietschlin also being along said west line of said Northwest Quarter of Section 13 and along said east line of said Northeast Quarter of Section 14 to the place of beginning, and containing 7.902 acres, more or less, of which 0.038 acre is in the Southwest Quarter of Section 12, 4.672 acres are in the Northwest Quarter of Section 13 and 3.192 acres are in the Northeast Quarter of Section 14 and subject to all legal highways and easements of record.

Bearings are to an assumed meridian and are used to express angles only.
