DESCRIPTION 1.0574 ACRES

Situated in the State of Ohio, County of Richland, City of Ontario, Township of Springfield, being part of the Southwest Quarter of Section Twenty-two (22), Township Twenty-one (21), Range Nineteen (19) and being a 0.53 acre parcel (PP No. 0386016811000) and a 0.53 acre parcel (PP No. 0386016810000) as recorded in Official Record Volume 1986, Page 271 and being more particularly described as follows;

Commencing at intersection of centerline of Park Avenue and the centerline of Lewis Road being referenced by a rebar with cap stamped "Craig 8195" found North 41°37'08" East, 40.13 feet;

Thence South 90°00'00" East, 231.66 feet with the centerline of said Park Avenue West to the **POINT OF BEGINNING** for the parcel herein described, being referenced by a rebar with cap stamped "Craig 8195" found North 02°05'49" West, 30.00 feet, said point also marking the southeast corner of lands now or formerly owned by Nova Lands, LLC as recorded in Official Record Volume 2672, Page 842;

Thence with the following Four (4) courses;

- 1. North 02°05'49" West, 286.41 feet with the east line of said Nova Lands lands to a rebar with cap stamped "Craig 8195 found in the south line of lands now or formerly owned by Wayman Edward Musick, et. al. As recorded in Official Record Volume 1061, Page 848;
- 2. North 88°46'46" East, 159.80 feet to a rebar with cap stamped "RGL 6687" found in the west line of lands nor or formerly owned by J Mark Investments, LLC as recorded in Official Record Volume 2243, Page 180;
- 3. South 02°07'47" East, 289.82 feet with the west line of said J Mark Investments lands to a point in the centerline of said Park Avenue West being referenced by a rebar with cap stamped "RGL 6687" found at 260.02 feet;
- 4. North 90°00'00" West, 160.05 feet with the centerline of said Park Avenue West to the point of beginning, containing 1.0574 acre, of which 0.5271 acre is in permanent parcel no. 0386016811000, and 0.5303 acre is in permanent parcel no. 0386016810000, being subject to all legal easements, restrictions and rights-of-way now on record.

Bearings are based on survey file GG-188 of the Richland County Tax Map Records, and are used to express angles only.
