DESCRIPTION OF 6.225 ACRE PARCEL WENDY FLAUGHER

Situated in the State of Ohio, County of Richland, Township of Springfield, lying in the Northwest Quarter and Southwest Quarter of Section Thirty (30), Township Twenty One (21), Range Nineteen (19), of an original tract conveyed to Wuthmann Rentals, LLC by deed of record in Official Record Volume 2989, Page 3017 (all references are to the records of the Recorder's Office, Richland County, Ohio) and being more particularly described as follows:

BEGINNING at a railroad spike found at the Southwest corner of the Northwest Quarter and the Northwest corner of the Southwest Quarter of said Section 30 in the centerline of Lohr Road (T.H. 45);

thence North 00°45'09" East, with the West line of the Northwest Quarter of said Section 30 and with the said centerline of said Lohr Road, a distance of 261.87 feet to a railroad spike set at the Southwest corner of a 1.226 acre tract conveyed to M.I. Pittman by deed of record in Official Record Volume 2771, Page 527, referenced by a 5/8" rebar found, South 89°12'02" East, a distance of 11.10 feet;

thence South 89°12'02" East, with the South line of said 1.226 acre tract, a distance of 360.77 feet to a capped "Stevens 7052" iron pin found at the Southwest corner of a 2.599 acre tract conveyed to J.M. & J. Gray by deed of record in Official Record Volume 2817, Page 428;

thence South 89°43'13" East, with the South line of said 2.599 acre tract, a distance of 235.57 feet to a 5/8" rebar found on the West line of a 2.176 acre tract conveyed to A.M. & J.D. Robbins by deed of record in Official Record Volume 2790, Page 598;

thence South 00°09'03" West, with the West line of said 2.176 acre tract, a distance of 267.48 feet to an iron pin set on the South line of the Northwest Quarter and the North line of the Southwest Quarter of said Section 30;

thence South 00°52'11" West, with the West line of said 2.176 acre tract and the West line of a 52.081 acre tract conveyed to A. Lewis by deed of record in Official Record Volume 2848, Page 404, a distance of 188.79 feet to an iron pin set at the Northeast corner of a 2.062 acre tract conveyed to H.E. & S.J. Bartolomea III by deed of record in Official Record Volume 2771, Page 814;

thence North 88°57'07" West, with the North line of said 2.062 acre tract, a distance of 598.92 feet to a survey spike found on the West line of the Southwest Quarter of said Section 30 and the centerline of said Lohr Road, passing by an iron pin set at a distance of 578.92 feet;

thence North 00°48'00" East, with the West line of the Southwest Quarter of said Section 30 and the centerline of said Lohr Road, a distance of 189.65 feet to the POINT OF BEGINNING, containing 6.225 total acres of land, more or less, of which 3.623 acres are in the Northwest quarter and 2.602 acres are in the Southwest quarter;

Subject, however, to all legal rights-of-ways and/or easements of record.

Iron pins set, where indicated, are iron rebar, five/eights (5/8) inch diameter, thirty (30) inches long with a plastic cap on top stamped "HANNING PS 8568".

The bearings herein are based on Richland County Engineer Survey HH-153.
