

SURVEYOR'S DESCRIPTION FOR NORMAN & HEIDI JONES

17,392 SQ. FT.

Situated in the City of Mansfield, County of Richland, State of Ohio, being part of Lots 10468 and 10469 and all of Lots 10470 and 10471 of the consecutively numbered Lots in said City as shown in plat volume 12, page 23 and being more particularly described as follows:

Beginning at an iron pin set in the northwest corner of said Lot 10471, said iron pin also being in the south right of way line of Edgewood Road (60');

Thence with the following SIX courses:

- S 89° 23' 40" E, 134.98 feet along the north line of said Lot 10471 and along the north line of said Lots 10470 and 10469, also being along said south right of way line of Edgewood Road (60') to an iron pin found in the northwest corner of a parcel of land conveyed to Dennis C. and Margaret E. Couch by official records volume 1755, page 730;
- 2) S 00° 11' 52" W, 121.61 feet along the west line of said land of Dennis C. and Margaret E. Couch to an iron pin found in the southwest corner of said land, said iron pin also being in the south line of said Lot 10468;
- 3) N 86° 46' 53" W, 34.91 feet along said south line of said Lot 10468 to a point being the southwest corner of said Lot, said point also being in the east line of said Lot 10470, and being referenced by an iron pin found S 00° 11' 52" W, 10.79 feet from said point;
- 4) S 00° 11' 52" W, 10.79 feet along said east line of said Lot 10470 to an iron pin found in the southeast corner of said Lot;
- 5) **S 89° 37' 49" W, 100.11 feet** along the south line of said Lot 10470 and along the south line of said Lot 10471 to a point being the southwest corner of said Lot 10471, said point being referenced by an iron pin set N 00° 11' 52" E, 1.00 feet from said point;
- N 00° 11' 52" E, 132.51 feet along the west line of said Lot 10471 to the place of beginning, passing through previously referenced iron pin set at 1.00 feet and containing 17,392 square feet, more or less of which 1,743 square feet are in part of Lot 10468, 2,469 square feet are in part of Lot 10469, 6,573 square feet are in Lot 10470 and 6,607 square feet are in Lot 10471, and subject to all legal highways and easements of record.

Bearing are to an assumed meridian and are used to express angles only.
