Thence turning and running South 00 deg. 51 min. 44 sec. West for 313.99 feet to an existing iron pin;

Thence turning and running North 83 deg. 09 min. 20 sec. West for 165.29 feet to an existing iron pin;

Thence turning and running North 00 deg. 00 min. 47 sec. East for 304.85 feet to the place of beginning.
