Situated in the Township of Sharon, County of Richland, State of Ohio and being part of the Northeast and Northwest quarters of Section 23, Township 21, Range 20 and being more fully described as follows:

**COMMENCING** at an existing railroad spike at the intersection of the centerline of County Highway 178 (Hinesville Road) with the North line of Section 23;

Thence running South 88 deg. 32 min. 34 sec. East along the North line of Section 23 for 1235.41 feet to the **PLACE OF BEGINNING** (a 5/8 inch rebar set South 01 deg. 27 min. 26 sec. West and 30.00 feet from this point);

Thence continuing South 88 deg. 32 min. 34 sec. East along said North line for 97.55 feet to an existing iron pipe at the Northwest corner of the Northeast quarter;

Thence turning and running South 88 deg. 47 min. 06 sec. East along the North line of Section 23 for 384.45 feet;

Thence turning and running South 01 deg. 12 min. 54 sec. West (passing a 5/8 inch rebar set at 30.00 feet) for a total distance of 322.00 feet to a 5/8 inch rebar set;

Thence turning and running North 88 deg. 47 min. 06 sec. West for 220.00 feet to a 5/8 inch rebar set;

Thence turning and running North 01 deg. 12 min. 54 sec. East for 100.00 feet to a 5/8 inch rebar set;

Thence turning and running North 88 deg. 41 min. 41 sec. West for 262.94 feet to a 5/8 inch rebar set;

Thence turning and running North 01 deg. 27 min. 26 sec. East (passing a 5/8 inch rebar set at 192.00 feet) for a total distance of 222.00 feet to the place of beginning.
