DESCRIPTION 9.5153 ACRES

Situated in the State of Ohio, County of Richland, Township of Franklin, being part of the Southeast Quarter of Section Twenty (20), Township Twenty-two (22), Range Eighteen (18) and being a 9.15 acre parcel (Permanent Parcel No. 0114012407000) now or formerly owned by Joseph M. and Stephanie M. Kososky as recorded in Official Record Volume 2435, Page 572 and a 0.40 acre parcel (Permanent Parcel No. 0114012406000) now or formerly owned by Joseph M. and Stephanie M. Kososky as recorded in Official Record Volume 2803, Page 311 of the Richland County Recorder's Records and being more particularly described as follows;

Commencing at a railroad spike found marking the northeast corner of the southeast quarter of Section 20, said railroad spike being in the centerline of Ernsberger Road (Township Highway 234);

Thence South 00°25'04" West, 550.00 feet with the east line of said quarter and the centerline of Ernberger Road to a railroad spike set marking the intersection of said Ernsberger Road and Linn Road (County Highway 232);

Thence South 83°32'04" West, 355.50 feet with the centerline of Linn Road to a mag nail set marking the **POINT OF BEGINNING** for the parcel herein described, said mag nail also marking the northwest corner of lands now or formerly owned by David and Kathy L. Rose as recorded in Official Record Volume 108, Page 637;

Thence with the following Eight (8) courses;

- 1. South 01°23'40" East, 358.76 feet with the west line of said Rose lands to a 5/8" rebar with cap stamped "Weigler 7747" set marking the southwest corner of said Rose lands, passing through a 5/8" rebar with cap stamped "Weigler 7747" set for reference at 25.00 feet;
- 2. South 89°28'50" East, 143.00 feet to a 1/2" iron pipe found in the south line of said Rose lands and marking the northwest corner of lands now or formerly owned by Steven G. and Loretta M. Hite, Trustees as recorded in Official Record Volume 2860 Page 30;
- 3. South 01°40'44" West, 430.22 feet with the west line of said Hite lands to a 5/8" rebar found in the west line of said Hite lands;
- 4. South 00°46'51" West, 100.00 feet with the west line of said Hite lands to a 5/8" rebar with cap stamped "Weigler 7747" Set in the north line of lands now or formerly owned by Lena Rose Smith, et.al; as recorded in Official Record Volume 879, Page 877, Official Record Volume 2350, Page 725 and Official Record Volume 2479, Page 422, Official Record Volume 2537, Page 676;
- 5. South 89°00'21" West, 523.83 feet with the north line of said Smith, et.al. Lands to wood post foundmarking the southeast corner of lands now or formerly owned by Michael D. Pawlikowski and Grace M. Custer as recorded in Official Volume 2890, Page 5;

- 6. North 01°28'13" West, 203.49 feet with the east line of said Pawlikowski lands to a 5/8" rebar found marking the southeast corner of a 3.0 acre parcel of land now or formerly owned by Joseph M. Kososky as recorded in Official Record Volume 2137, Page 476, passing through a rebar with cap stamped "Craig 8195" at 1.50 feet
- 7. North 01°20'07" East, 653.20 feet with the east line of said Kososky 3.0 acre parcel to a mag nail set in the centerline of said Linn Road, passing through a 5/8" rebar with cap stamped "Weigler 7747" set for reference at 622.20 feet;
- 8. North 83°32'04" East, 378.40 feet with the centerline of said Linn Road, to the point of beginning, containing 9.5153 acres, of which 9.0485 acres are in Permanent Parcel No. 0114012407000, and 0.4668 acre is in Permanent Parcel No. 0114012406000, being subject to all legal easements, restrictions and rights-of-way now on record.

Bearings are based on survey file LL-198 of the Richland County Tax Map Records, and are used to express angles only.
