

SURVEYOR'S DESCRIPTION FOR RICHARD DAWSON

6,500 square feet

Situated in the Township of Madison, County of Richland, State of Ohio, being part of the Northeast Quarter of Section 14, Township 21, Range 18, being Lot 205 and part of Lot 206 of Lincoln Fields Allotment as recorded in plat volume 15, page 20 and being more particularly described as follows:

Beginning at an iron pin set in the southeast corner of said Lot 205, said iron pin also being in the north right of way line of Duke Avenue (50');

Thence with the following FOUR courses:

- S 89° 04' 12" W, 52.00 feet along the south line of said Lot 205 and along the south line of said Lot 206, also being along said north right of way line of Duke Avenue (50') to a point being the southeast corner of a parcel of land conveyed to Debra D. Baker by official records volume 2190, page 198, said point being referenced by an iron pin set S 89° 04' 12" W, 8 .00 feet from said point;
- N 00° 23' 39" W, 125.00 feet along the east line of said land of Debra D. Baker to a point being the northeast corner of said land, said point being in the north line of said Lot 206 and being referenced by an iron pin set S 89° 04' 12" W, 8 .00 feet from said point;
- N 89° 04' 12" E, 52.00 feet along said north line of said Lot 206 and along the north line of said Lot 205 to an iron pin found in the northeast corner of said Lot 205;
- 4) S 00° 23' 39" E, 125.00 feet along the east line of said Lot 205 to the place of beginning and containing 6,500 square feet, more or less, of which 6,250 square feet are in Lot 205 and 250 square feet are in a part of Lot 206 and subject to all legal highways and easements of record.

- 4) S 00° 23' 39" E, 125.00 feet along the west line of said land of Richard Dawson Sr. to the **true place of beginning** and containing 1,000 square feet, more or less, and subject to all legal highways and easements of record.
