

## SURVEYOR'S DESCRIPTION FOR STEVEN DORNER

## **5.025** Acres

Situated in the Township of Perry, County of Richland, State of Ohio, being part of the Southwest Quarter of Section 14, Township 19, Range 19 and being more particularly described as follows:

**Commencing** at a railroad spike found in the northwest corner of said Southwest Quarter, said railroad spike also being in the intersection of the centerline of Darlington North Road (C.H. 121)(60') and the centerline of Woodberry Road (C.H. 28)(60');

Thence S 00° 22′ 32″ W, 440.39 feet along the west line of said Southwest Quarter also being along said centerline of Darlington North Road (C.H. 121)(60′) to a point being the southwest corner of a parcel of land conveyed to Richard A. and Jill S. Steel by official records volume 1687, page 291, said point being referenced by an iron pin found S 88° 40′ 32″ E, 30.00 feet from said point and being the **true place of beginning**;

Thence with the following SIX courses:

- S 88° 40' 32" E, 1,100.00 feet along the south line of said land of Richard A. and Jill S. Steel to an iron pin found in the southeast corner of said land, said iron pin also being in the west line of a parcel of land conveyed to Richland Farms LLC by official records volume 2765, page 464 and passing through previously referenced iron pin found at 30.00 feet;
- 2) S 00° 22' 32" W, 248.05 feet along said west line of said land of Richland Farms LLC to an iron pin set and passing through an iron pin found at 200.00 feet;
- 3) N 88° 39' 22" W, 549.96 feet to an iron pin set;
- 4) N 00° 22' 07" E, 97.80 feet to an iron pin set;
- N 88° 40' 14" W, 550.03 feet to a point being in said west line of said Southwest Quarter, said point also being in said centerline of Darlington North Road (C.H. 121)(60') and passing through an iron pin set at 520.06 feet;
- N 00° 22' 32" E, 150.02 feet along said west line of said Southwest Quarter and along said centerline of Darlington North Road (C.H. 121)(60') to the **true place of beginning** and containing 5.025 acres, more or less, and subject to all legal highways and easements of record.

**Commencing** at a railroad spike found in the northwest corner of said Southwest Quarter, said railroad spike also being in the intersection of the centerline of Darlington North Road (C.H. 121)(60') and the centerline of Woodberry Road (C.H. 28)(60');

Thence S 00° 22′ 32″ W, 590.41 feet along the west line of said Southwest Quarter also being along said centerline of Darlington North Road (C.H. 121)(60′) to a point, said point being referenced by an iron pin set S 88° 40′ 14″ E, 29.97 feet from said point and being the **true place of beginning**;

Thence with the following SIX courses:

- 1) S 88° 40' 14" E, 550.03 feet to an iron pin set and passing through previously referenced iron pin set at 29.97 feet;
- 2) S 00° 22' 07" W, 97.80 feet to an iron pin set;
- 3) S 88° 39' 22" E, 549.96 feet to an iron pin set in the west line of a parcel of land conveyed to Richland Farms LLC by official records volume 2765, page 464;
- 4) S 00° 22' 32" W, 151.95 feet along said west line of said land of Richland Farms LLC to an iron pin found in the northeast corner of a parcel of land conveyed to Steven R. and Terri L. Dorner by official records volume 2759, page 236;
- 5) N 88° 40′ 32″ W, 1,100.00 feet along the north line of said land of Steven R. and Terri L. Dorner to a point being the northwest corner of said land, said point also being in said west line of said Southwest Quarter and being in said centerline of Darlington North Road (C.H. 121)(60′) and passing through an iron pin found at 1,070.00 feet;
- N 00° 22' 32" E, 249.98 feet along said west line of said Southwest Quarter and along said centerline of Darlington North Road (C.H. 121)(60') to the **true place of beginning** and containing 5.075 acres, more or less, and subject to all legal highways and easements of record.
