## **DESCRIPTION** LOT 142, 144, VACATED ALLEY, **PART OUTLOT 31**

Situated in the State of Ohio, County of Richland, Township of Troy, Village of Lexington and being Lot number 142, 144 and vacated alley and part of Outlot 31 of the consecutively numbered inlots and outlots in said Village, now or formerly owned by Ralph W. and Jeanette M. Brown as recorded in Official Record Volume 384, Page 746, and being more particularly described as follows:

BEGINNING at a rebar with cap stamped "Stevens 7052" found marking the northeast corner of Lot 142, said rebar being in the west right-of-way line of Maple Street (49.5 feet in width);

Thence with the following Six (6) courses;

- 1. South 02°41'40" West, 139.06 feet with the west right-of-way line of said Maple Street to a point being referenced by a rebar with cap stamped "Stevens 7052" found, North 87°05'11" West, 4.00 feet, said point also marking the northeast corner of Lot 146;
- 2. North 87°05'11" West, 336.41 feet with the north line of Lot 146 and the north line of Outlot 30 to a 5/8" rebar with cap stamped "Weigler 7747" set;
- North 02°41'40" East, 139.09 feet to a crimped iron pipe in concrete found marking the southeast corner of lands now or formerly owned by Joel A. Likens as recorded in Deed Volume 809, Page 498;
- South 87°45'09" East, 204.38 feet with the south line of lands now or formerly owned by R. Michael Arter as recorded in Official Record Volume 512, Page 593 to a point in the west line of Lot 140, passing through crimped iron pipe in concrete at 38.00 feet and 199.01 feet;
- 5. South 02°41'40" West, 2.50 feet with the west line of said Lot 140 to a rebar with cap stamped "Stevens 7052" found marking the northwest corner of Lot 142;
- 6. South 87°07'27" East, 132.04 feet with the north line of Lot 142, to the point of beginning, containing 1.0795 acre (47024.28 Square Feet), of which 8714.33 square feet are in Lot 142, 2178.58 square feet are in a vacated alley, 7462.16 square feet are in Lot 144 and 28,669.21 square feet are in Part Outlot 31, being subject to all legal easements, restrictions and rights-of-

## DESCRIPTION PART OUTLOT 31

Situated in the State of Ohio, County of Richland, Township of Troy, Village of Lexington and being part of Outlot 31 of the consecutively numbered outlots in said Village, now or formerly owned by Ralph W. and Jeanette M. Brown as recorded in Official Record Volume 384, Page 746, and being more particularly described as follows;

**BEGINNING** at a rebar with cap stamped "Stevens 7052" found marking the southwest corner of Outlot 31, said rebar also marking the northwest corner of Outlot 30 being lands now or formerly owned by Wesley and Kelly Morrison as recorded in Official Record Volume 2739, Page 487, and being in the east line of lands now or formerly owned by Lexington Grace Brethren Church, a corporation as recorded in Deed Volume 822, Page 114;

Thence with the following Four (4) courses;

- 1. North 00°31'07" East, 137.82 feet with the east line of said Lexington Brethren Church lands to a 5/8" rebar with cap stamped "Weigler 7747" set marking the southwest corner of lands now or formerly owned by Joel A. Likens as recorded in Deed Volume 809, Page 498
- 2. South 87°45'09" East, 119.85 feet with the south line of said Likens lands to a crimped iron pipe in concrete found;
- 3. South 02°41'40" west, 139.09 feet to a 5/8" rebar with cap stamped "Weigler 7747" set in the south line of Outlot 31;
- 4. North 87°05'11" West, 114.61 feet with the south line of Outlot 31 to the point of beginning, containing 0.3725 acre (16225.91 Square Feet), being subject to all legal easements, restrictions and rights-of-way now on record.

The Grantees, his heirs and assigns do hereby covenant and agree that the parcel of land described in this instrument or any portion thereof does not constitute a principal building site under the applicable zoning and will not be conveyed by said grantees, heirs and assigns independent and separate from any adjoining or contiguous parcel fronting on a public highway or street.
