LEGAL DESCRIPTION

August 12, 2022

Situated in the Township of Madison, County of Richland, State of Ohio, and being a part of the Northwest Quarter of Section 35, Township 21-North, Range 18-West and being a parcel conveyed to Jeremiah A. Pocock and Brittany Pocock, by official record volume 1981, page 718 of the Richland County Recorder's records and being more particularly described as follows:

Commencing at a concrete monument found in the northwesterly corner of Lot 17 of Maple Hill #1 as recorded in plat volume 16, page 27, said monument also being in the easterly right of way line of Mansfield Lucas Road-(C.H. 300)(60' R/W) and being in the southerly line of a parcel of land conveyed to James W. Miley and Beverly S. Miley by official record volume 2763, page 211;

Thence, South 49 degrees 32 minutes 22 seconds West, 30.01 feet along said southerly line of Miley parcel to a point being the southwesterly corner of said parcel, said point also being in the centerline of said Mansfield Lucas Road and being in the easterly line of a parcel conveyed to Richard N. Bays by official record volume 1788, page 812;

Thence, North 41 degrees 30 minutes 05 seconds West, 51.16 feet along said centerline of Mansfield Lucas Road also being along said easterly line of said Bays parcel to a point in the northeast corner thereof, said point being referenced by an iron pipe found South 48 degrees 38 minutes 46 seconds West, 29.55 feet therefrom, and being the Place of Beginning of the parcel described herein:

Thence, the following FOUR courses:

- 1. South 48 degrees 38 minutes 46 seconds West, 209.78 feet along the northerly line of said Bays parcel to a point in the northwesterly corner thereof, said point also being on the easterly line of a parcel conveyed to Steven L. Davis by official record volume 2298, page 648, passing through an iron pipe found for reference at 29.55 feet and 209.28 feet;
- 2. North 41 degrees 43 minutes 59 seconds West, 54.90 feet along said easterly line of Davis parcel to an axle found in the northeasterly corner thereof, also being on the southerly line of a parcel conveyed to Dellno C. and Brandy A. First by official record volume 2718, page 86;
- 3. North 48 degrees 43 minutes 39 seconds East, 210.00 feet along the southerly line of said First parcel to a point in a southeasterly corner thereof, being on the aforementioned centerline of Mansfield Lucas Road, and passing through an iron pipe found for reference at 179.88 feet;
- 4. South 41 degrees 30 minutes 05 seconds East, 54.60 feet along said centerline of Mansfield Lucas Road to the **Place of Beginning**, containing 0.2638 of an acre (11491.90 square feet), more or less, and subject to all legal highways, easements, leases, and use restrictions of record.

Bearings are to an assumed meridian and are used to express angles only.
