

SURVEYOR'S DESCRIPTION FOR GREGORY & NEDRA JONES

6.607 Acres

Situated in the Township of Worthington, County of Richland, State of Ohio, being part of the Southeast Quarter of Section 19, Township 21, Range 17 and being more particularly described as follows:

Commencing at a railroad spike found in the northwest corner of said Southeast Quarter, said railroad spike also being in the centerline of Cassel Road (T.H. 393)(60');

S 89° 46' 32" E, 573.66 feet along the north line of said Southeast Quarter, also being along said centerline of Cassel Road (T.H. 393)(60') to a point being the northeasterly corner of a parcel of land conveyed to Bradley Ranshaw by official records volume 530, page 298, said point being referenced by an iron pin found S 08° 23' 45" W, 29.56 feet from said point and being the **true place of beginning**;

Thence with the following **SEVEN** courses:

- 1) S 89° 46' 32" E, 284.29 feet and continuing along said north line of said Southeast Quarter and along said centerline of Cassel Road (T.H. 393)(60') to a point, said point being referenced by an iron pin set S 00° 13' 28" W, 30.00 feet from said point;
- 2) S 00° 13' 28" W, 304.89 feet to an iron pin set and passing through previously referenced iron pin set at 30.00 feet;
- 3) S 89° 46′ 32″ E, 400.00 feet to an iron pin set in a west line of a parcel of land conveyed to Jason D. and Jodi L. Burgholder by official records volume 1452, page 312;
- 4) S 00° 13' 28" W, 164.11 feet along said west line of said land of Jason D. and Jodi L. Burgholder to an iron pin found in an interior corner of said land;
- 5) S 58° 18' 21" W, 599.03 feet along the northwesterly line of said land of Jason D. and Jodi L. Burgholder to an iron pin in an interior corner of said land, said iron pin also being in the southeasterly corner of a parcel of land conveyed to Bradley R. Ranshaw by official records volume 2180, page 432;
- 6) N 16° 51' 49" W, 690.62 feet along the easterly line of said land of Bradley R. Ranshaw and along the easterly line of a parcel of land conveyed to Brad Ranshaw by official records volume 503, page 683 to a metal fence post found in the southerly corner of said land of Bradley Ranshaw as described in said official records volume 530, page 298;
- 7) N 12° 24' 07" E, 128.48 feet along the easterly line of said land of Bradley Ranshaw to the true place of beginning and containing 6.607 acres, more or less, and subject to all legal highways and easements of record.

Thence with the following **EIGHT** courses:

- 1) S 89° 46' 32" E, 50.00 feet and continuing along said north line of said Southeast Quarter and along said centerline of Cassel Road (T.H. 393)(60') to a railroad spike found in the northwest corner of a parcel of land conveyed to Gregory L. and Nedra L. Jones by deed volume 873, page 427;
- 2) S 00° 13' 28" W, 218.00 feet along the west line of said land of Gregory L. and Nedra L. Jones to wood fenced post found in the southwest corner of said land;
- 3) S 89° 46' 32" E, 300.00 feet along the south line of said land of Gregory L. and Nedra L. Jones to a point being the southeast corner of said land, said point being referenced by a wood post found N 00° 13' 28" E, 1.45 feet from said point;
- 4) N 00° 13′ 28″ E, 218.00 feet along the east line of said land of Gregory L. and Nedra L. - 8) N 00° 13' 28" E, 304.89 feet to the true place of beginning, passing through previously referenced iron pin set at 274.89 feet and containing 1.298 acres, more or less, and subject to all legal highways and easements of record.
