

SURVEY DESCRIPTION PARCEL "A"

PART OF THE SW QUARTER OF SECTION 22 JEFFERSON TOWNSHIP RICHLAND COUNTY, OHIO

Situated in the Township of Jefferson, County of Richland, State of Ohio and being a part of the Southwest quarter of Section 22 of Township 19 North, Range 18 West, and being more particularly described as follows:

Commencing at the northeast corner of the southwest quarter of Section 22, said point being referenced by an iron pin found on a bearing of North 00 degrees 33 minutes 45 seconds West and at a distance of 45.85 feet; Thence, South 89 degrees 48 minutes 41 seconds West 303.47 feet to a point in the centerline of Durbin Road (T.H. 404), said point marking the northeast corner of a parcel currently owned by S.K. Whatman (O.R.V. 2157, Page 742), the same being the northwest corner or a parcel currently owned by R. & S. Crider (O.R.V. 514, Page 456), said point being referenced by an iron pin found on a bearing of South 01 degree 19 minutes 59 seconds East and at a distance of 23.48 feet; Thence, South 01 degree 19 minutes 59 seconds East with the common line of said Whatman and Crider parcels and passing through said iron pin found for a total distance of 371.25 feet to an iron pin found; Thence South 26 degrees 43 minutes 40 seconds East 212.70 feet with said common line to an iron pin set marking the place of beginning of the parcel herein described;

Thence, South 26 degrees 43 minutes 40 seconds East 95.05 feet to an iron pin found;

Thence, South 89 degrees 50 minutes 49 seconds West 70.05 feet to an iron pin set;

Thence, North 17 degrees 47 minutes 33 seconds East 89.35 feet to the place of beginning, containing 0.07 acre according to a survey by Chad F. Craig P.S. #8195 for Seiler & Craig Surveying, Inc. on September 2, 2022, but subject to all easements, right of ways and highways of record.

Iron pins set are 5/8" rods with caps stamped "CRAIG 8195".

Bearings are based on State Plane Grid North, NAD 83 (2011), Geoid 18A, Ohio North Zone and are intended to be used for angular determination only.

PART OF THE SW QUARTER OF SECTION 22 JEFFERSON TOWNSHIP RICHLAND COUNTY, OHIO

Situated in the Township of Jefferson, County of Richland, State of Ohio and being a part of the Southwest quarter of Section 22 of Township 19 North, Range 18 West, and being more particularly described as follows:

Commencing at the northeast corner of the southwest guarter of Section 22, said point being referenced by an iron pin found on a bearing of North 00 degrees 33 minutes 45 seconds West and at a distance of 45.85 feet; Thence, South 89 degrees 48 minutes 41 seconds West 303.47 feet to a point in the centerline of Durbin Road (T.H. 404), said point marking the northeast corner of a parcel currently owned by S.K. Whatman (O.R.V. 2157, Page 742), the same being the northwest corner or a parcel currently owned by R. & S. Crider (O.R.V. 514, Page 456), said point being referenced by an iron pin found on a bearing of South 01 degree 19 minutes 59 seconds East and at a distance of 23.48 feet; Thence, South 01 degree 19 minutes 59 seconds East with the common line of said Whatman and Crider parcels and passing through said iron pin found for a total distance of 371.25 feet to an iron pin found; Thence, South 26 degrees 43 minutes 40 seconds East with said common line, passing through an iron pin set at 212.70 feet for a total distance of 307.75 feet to an iron pin found; Thence, South 89 degrees 50 minutes 48 seconds West with said common line passing through an iron pin set at 70.05 feet for a total distance of 238.61 feet to an iron pin found; Thence, South 00 degrees 28 minutes 20 seconds East 246.85 feet with said common line to an iron pin set marking the place of beginning of the parcel herein described;

Thence, South 00 degrees 28 minutes 21 seconds East 440.93 feet to an iron pin found on the north line of a parcel currently owned by D. & S. Stein (O.R.V. 2887, Page 58);

Thence, South 89 degrees 31 minutes 53 seconds West with the north line of said Stein parcel 35.22 feet to an iron pin set;


Thence, North 00 degrees 28 minutes 21 seconds West 441.13 feet to an iron pin set;
