thence North 01°01'23" West, with the West line of the Southwest Quarter of said Section 11, a distance of 726.30 feet to a point on a Southwest corner of a 0.28 acre tract conveyed to The Richland County Board of Park Commissioners by deed of record in Official Record Volume 1793, Page 663, passing a capped "Craig 8195" iron pin found, a distance of 685.30 feet;

thence South 36°17'18" East, with a South line of said 0.28 acre tract, a distance of 54.14 feet to a capped "Seiler & Craig" iron pin found on the Southeast corner of said 0.28 acre tract and the West line of a 23.22 acre tract conveyed to said The Richland County Board of Park Commissioners;
