LEGAL DESCRIPTION

PARCEL "A"

September 13, 2022

Situated in the Township of Jefferson, County of Richland, State of Ohio, and being a part of the Northwest Quarter of Section 27, Township 19-North, Range 18-West and being a portion of a parcel conveyed to Michael F. & Phyllis A. Patterson by official record volume 631, page 26 of the Richland County Recorder's records and being more particularly described as follows:

Commencing at an iron pin set marking the northeast corner of said Quarter, being in the centerline of Wagner Road-(T.H. 394)(60' R/W);

Thence, South 89 degrees 41 minutes 41 seconds West, 120.00 feet along the north line of said Quarter and said centerline to an iron pin set, the Place of Beginning for the parcel herein described;

Thence, the following FOUR courses:

- 1. South 00 degrees 24 minutes 37 seconds East, 1037.11 feet traversing said Patterson parcel to an iron pin set, and passing through an iron pin set for reference at 30.00 feet;
- 2. **South 89 degrees 41 minutes 41 seconds West, 1207.77 feet** traversing said Patterson parcel to an iron pin set on the east line of a parcel conveyed to Christine Mitchell by official record volume 2770, page 640;
- 3. North 00 degrees 26 minutes 04 seconds West, 1037.11 feet along the east line of said Mitchell parcel and the east line of a parcel conveyed to Judith A. Davis & Ralph W. Greer by official record volume 2665, page 644 to a railroad spike found in the northeast corner of said Greer parcel, passing through an iron pin found for reference at 1007.11 feet, and being on the north line of said Quarter, the centerline of Wagner Road;
- 4. North 89 degrees 41 minutes 41 seconds East, 1208.20 feet along the north line of said Quarter and said centerline to the Place of Beginning, containing 28.7605 acres, more or less, and subject to all legal highways, easements, leases, and use restrictions of record.

LEGAL DESCRIPTION

PARCEL "B"

Situated in the Township of Jefferson, County of Richland, State of Ohio, and being a part of the Northwest and Southwest Quarters of Section 27, Township 19-North, Range 18-West and being a portion of a parcel conveyed to Michael F. & Phyllis A. Patterson by official record volume 631, page 26 of the Richland County Recorder's records and being more particularly described as follows:

Beginning for the same at an iron pin set marking the northeast corner of said Northwest Quarter, being in the centerline of Wagner Road-(T.H. 394)(60' R/W);

Thence, the following SEVEN courses:

- 1. South 00 degrees 24 minutes 37 seconds East, 2586.57 feet along the east line of said Northwest Quarter to an iron pin set in the southeast corner thereof, and passing through an iron pin set for reference at 25.00 feet;
- 2. **South 00 degrees 47 minutes 45 seconds East, 874.50 feet** along the east line of said Southwest Quarter to an iron pin found in the northeast corner of a parcel conveyed to David C. Pamer & Mathias G. Pamer by official record volume 2915, page 312;
- 3. **South 89 degrees 05 minutes 22 seconds West, 1332.68 feet** along the north line of said Pamer parcel to an iron pin found in the southeast corner of a parcel conveyed to Carol E. Myers by official record volume 360, page 889;
- 4. **North 00 degrees 26 minutes 04 seconds West, 2438.01 feet** along the east line of said Myers parcel and the east line of a parcel conveyed to Christine Mitchell by official record volume 2770, page 640 to an iron pin set;
- 5. North 89 degrees 41 minutes 41 seconds East, 1207.77 feet traversing said Patterson parcel to an iron pin set;
- 6. North 00 degrees 24 minutes 37 seconds West, 1037.11 feet traversing said Patterson parcel to an iron pin set on the north line of said Northwest Quarter, said centerline of Wagner Road, and passing through an iron pin set for reference at 1007.11 feet;

7. **North 89 degrees 41 minutes 41 seconds East, 120.00 feet** along the north line of said Quarter and said centerline to the **Place of Beginning**, containing a total of 76.9876 acres, more or less, of which 50.3119 acres are located within said Northwest Quarter and 26.6757 acres are located within said Southwest Quarter, and subject to all legal highways, easements, leases, and use restrictions of record.
