## **DESCRIPTION** LOT 1511, PART OF LOT 1510, & PART OF VACATED ALLEY **JENNERS ADDITION, PLAT VOLUME 7, PAGE 20** CITY OF SHELBY, RICHLAND COUNTY, OHIO

DESCRIPTION: Being Lot 1511, part of Lot 1510, and part of a vacated alley in Jenners Addition, Plat Volume 7, Page 20, in the City of Shelby, Richland County, Ohio, and being more particularly described as follows:

The real point of beginning being a 3" survey spike set at the intersection of the northerly right-of-way line of Franklin Avenue (60 feet in width) and the easterly right-of-way line of Ashland Railway (100 feet in width), said point also being on the westerly line of a 20 foot wide vacated alley;

- 1) thence on a curve to the right having a radius of 1860.08 feet, a delta of 05°17'26", and an arc length of 171.76 feet (chord bearing N10°36'09"W, 171.70 feet), along the easterly right-of-way line of said railroad (westerly rightof-way of said vacated alley), to an iron pin set, having passed through an iron pin set for reference at 25.00 feet;
- 2) thence N07°57'30"W, continuing along said railroad and vacated alley right-of-way lines, a distance of 5.24 feet to a "Blosser" monument found;
- thence N47°26'45"E, a distance of 24.30 feet to an iron pin set on the northerly line of Lot 1510 (southerly line of Lot 1504) and on the easterly right-of-way line of said vacated alley;
- thence S07°57'30"E, along a westerly line of Lot 1510 and the easterly right-of-way line of said vacated alley, a distance of 13.30 feet to a point referenced by an iron pin found N42°37'00"W, 1.50 feet;
- thence S42°37'00"E, passing for reference an iron pin found 138.94 feet, a total distance of 139.05 feet to the 5) southerly line of Lot 1510, said point also being on the northerly right-of-way line of Franklin Avenue;
- 6) thence S47°26'45"W, along the southerly line of Lots 1510 and 1511 and the northerly right-of-way line of Franklin Avenue, a distance of 110.73 feet to the real point of beginning;

and containing 9,848.92 square feet – {3,812.68 square feet in Lot 1511, 2,489.13 square feet in part of Lot 1510, and 3,547.11 square feet within the vacated alley}, more or less, but subject to all legal easements and public rights-ofway now on record. All iron pin set are 5/8" diameter, 30" long rebar with caps stamped "Krocka & Assoc". Bearings are based on a survey by Charles A. Kerg dated February 20, 1989.
