

SURVEY DESCRIPTION PARCEL "A"

PART OF THE NE QUARTER OF SECTION 34 CASS TOWNSHIP RICHLAND COUNTY, OHIO

Situated in the Township of Cass, County of Richland, State of Ohio and being a part of the Northeast quarter of Section 34 of Township 23 North, Range 19 West, and being more particularly described as follows:

Beginning for the same at a railroad spike found and accepted as marking the northwest corner of the northeast quarter of Section 34, the same being a point in the centerline of Miller road (T.H. 195); Thence, North 89 degrees 47 minutes 03 seconds East with the north line of said quarter section, 1318.55 feet to a point referenced by an iron pin found on a bearing of North 00 degrees 50 minutes 55 seconds West and at a distance of 2.94 feet, the same being the northwest corner of a parcel currently owned by E. & V. Burkholder (O.R.V. 2930, Page 671);

Thence, South 00 degrees 50 minutes 55 seconds East with the west line of said Burkholder parcel and the southerly prolongation thereof, passing through an iron pin found at 539.78 feet, for a total distance of 2675.51 feet to an iron pin found on the south line of said quarter and marking the southwest corner of a parcel currently owned by J. & E. Burkholder (O.R.V. 1979, Page 501);

Thence, South 89 degrees 59 minutes 47 seconds West with the south line said quarter section 450.51 feet to an iron pin set;

Thence, North 00 degrees 44 minutes 35 seconds West 500.00 feet to an iron pin set;

Thence, South 89 degrees 59 minutes 47 seconds West passing through an iron pin set at 853.02 feet, for a total distance of 873.02 feet to a point on the west line of said quarter, and in said centerline;

Thence, North 00 degrees 44 minutes 35 seconds West with said west line and said centerline 2170.55 feet to the place of beginning, containing 71.04 acres according to a survey by Chad F. Craig P.S. #8195 for Seiler & Craig Surveying, Inc. on September 23, 2022, but subject to all easements, right of ways and highways of record.

Iron pins set are 5/8" rods with caps stamped "CRAIG 8195".
