

BASIS OF BEARING IS STATE PLANE GRID NORTH NAD 83 (2011), GEOID 18A, OHIO NORTH ZONE.



SURVEY DESCRIPTION

PART OF THE SE QUARTER OF SECTION 13 CITY OF ONTARIO, SPRINGFIELD TOWNSHIP RICHLAND COUNTY, OHIO

Situated in the City of Ontario, Township of Springfield, County of Richland, State of Ohio and being a part of the Southeast quarter of Section 13 of Township 21 North, Range 19 West, and being more particularly described as follows:

Beginning for the same at an iron pin found and accepted as marking the northeast corner of Lot #3267, Thence, with a curve to the right having a central angle of 1 degree 43 minutes 48 seconds, a radius of 970.00 feet, an arc length of 29.29 feet, a chord bearing of South 70 degrees 17 minutes 50 seconds East, and a chord distance of 29.29 feet, to an iron pin set;

Thence, South 00 degrees 20 minutes 38 seconds West passing through an iron pin set for reference at a distance of 138.40 feet, a total distance of 183.20 feet to a point;

Thence, North 72 degrees 52 minutes 13 seconds West 87.61 feet to a point marking the southeast corner of Lot #3267 and being referenced by an iron pin set on a bearing of North 18 degrees 53 minutes 37 seconds East and at a distance of 47.87 feet;

Thence, North 18 degrees 53 minutes 37 seconds East with the easterly line of said lot, passing through said iron pin set, a total distance of 176.80 feet to the place of beginning, containing 0.24 acre according to a survey by Chad F. Craig P.S. #8195 for Seiler & Craig Surveying, Inc. on October 3, 2022, but subject to all easements, right of ways and highways of record.

Iron pins set are 5/8" rods with caps stamped "CRAIG 8195".

Bearings are based on State Plane Grid North, NAD 83 (2011), Geoid 18A, Ohio North Zone and are intended to be used for angular determination only.

The grantees, his heirs and assigns do hereby covenant and agree that the parcel of land described in this instrument or any portion thereof does not constitute a principal building site under applicable zoning.
