

SURVEYOR'S DESCRIPTION FOR RONALD & REGINA BROKAW

2.526 Acres

Situated in the Township of Jefferson, County of Richland, State of Ohio, being part of the Northwest Quarter of Section 17, Township 19, Range 18 and being more particularly described as follows:

Beginning at a railroad spike found in the intersection of the centerline of Renie Road (T.H. 117)(60') and the centerline of Bollinger Road (T.H. 416)(40');

Thence with the following FIVE courses:

- N 00° 37' 11" E, 303.52 feet along said centerline of Renie Road (T.H. 117)(60') to a point, said point being referenced by an iron pin set S 73° 41' 26" E, 25.00 feet from said point;
- 2) **S 73° 41' 26" E, 494.81 feet** to an iron pin found in the northwesterly corner of a parcel of land conveyed to Stephen W. and Mary Jane Sklenicka by official records volume 2616, page 571 and passing through previously reference iron pin set at 25.00 feet;
- S 17° 22' 20" W, 236.00 feet along the westerly line of said land of Stephen W. and Mary Jane Sklenicka to a point being the southwesterly corner of said land, said point also being in said centerline of Bollinger Road (T.H. 416)(40') and passing through an iron pin found at 216.01 feet;
- 4) N 71° 08' 54" W, 203.35 feet along said centerline of Bollinger Road (T.H. 416)(40') to a point of curve, said point being referenced by an iron pin set N 18° 39' 22" E, 20.11 feet from said point;
- Westerly and continuing along said centerline of Bollinger Road (T.H. 416)(40') on a curve to the left having a radius of 312.00 feet, an arc length of 219.86 feet, a delta angle of 40° 22' 31", a chord length of 215.34 feet and a chord bearing of S 88° 39' 51" W to the place of beginning and containing 2.526 acres, more or less, and subject to all legal highways and easements of record.
