

## DESCRIPTION OF 4,430 SQUARE FEET PARCEL CHAD PATRICK

Situated in the State of Ohio, County of Richland, City of Shelby, Part of Inlot 499, of an original tract conveyed to Twenty-Four Properties, LLC by deed of record in Official Record Volume 2901, Page 717 (all references are to the records of the Recorder's Office, Richland County, Ohio) and being more particularly described as follows:
