BEGINNING at the northwest corner of said Lot 1886, being referenced by a 3/4" iron pipe found South 88°57'15" West, 0.14 feet, said point also marking the intersection of the east right-of-way line of Sturges Avenue (80 feet in width) and the south right-of-way line of a 15 foot wide alley, and being more particulally described as follows;

Thence with the following Four (4) courses;

- 1. North 88°57'15" East, 99.75 feet with the south right-of-way line of said 15 foot Alley to a rebar with cap stamped "PS 7016" found;
- 2. South 00°05'42" west, 54.95 feet to a 1/2" iron pipe found in the south line of Lot 1886 and north line of Lot 1885;
- 3. South 88°57'15" West, 99.61 feet with the line common to Lot 1885 and Lot 1886 to a point in the east right-of-way line of said Sturges Avenue, said point being referenced by a 1/2" iron pipe found North 59°55'46" West, 0.26 feet;
- 4. North 00°03'03" West, 54.94 feet with the east right-of-way line of said Sturges Avenue, to the point of beginning, containing 5475.73 square feet, being subject to all legal easements, restrictions and rights-of-way now on record.

BEGINNING at a 5/8" rebar with cap stamped "Weigler 7747" set marking the southwest corner of said Lot 1887, said point also marking the intersection of the east right-of-way line of Sturges Avenue (80 feet in width) and the north right-of-way line of a 15 foot wide alley, and being more particulaly described as follows,;

Thence with the following Four (4) courses;

- 1. North 00°03'03" West, 25.41 feet with the east right-of-way line of Sturges Avenue to a point being referenced by a 1/2" iron pipe found South 89°13'55" West, 0.14 feet;
- 2. North 89°13'55" East, 97.82 feet to a 1/2" iron pipe found;
- South 00°26'29" East, 24.93 feet to a 5/8" rebar with cap stamped "Weigler 7747" set in the north right-of-way line of said 15 foot alley;
- South 88°57'15" West, 98.00 feet with the north right-of-way line of said 15 foot Alley, to the point of beginning, containing 2464.04 square feet, being subject to all legal easements, restrictions and rights-of-way now on record.
