DESCRIPTIONET 17.1269 ACRES

Situated in the State of Ohio, County of Richland, Township of Springfield, being part of the Southwest Quarter of Section Five (5), Township Twenty-one (21), Range Nineteen (19) and being a 15.791 acre parcel and a 1.59 acre parcel now or formerly owned by Danny Joe and Karen Ann Williams as recorded in Official Record Volume 95, Page 477 and being more particularly described as follows;

BEGINNING at a mag nail found marking the southeast corner of the southwest quarter of Section 5, said railroad spike being in the centerline of Beam Road (County Highway 51);

Thence with the following Six (6) courses;

- North 89°14'09" West, 459.33 feet with the south line of said guarter and centerline of said Beam Road to a point being referenced by a 5/8" rebar with cap stamped "Weigler 7747" set North 01°50'20" West, 30.00', said point also marking the southeast corner of lands now or formerly owned by John C. Young as recorded in Official Record Volume 2993, Page 1741;
- North 01°50'20" West, 299.94 feet to a 5/8" rebar found marking a corner common to said Williams lands and said Young lands;
- North 89°15'25" West, 189.39 feet with the north line of said Young lands to a rebar with cap stamped "Seiler 6869" found marking the northwest corner of Young lands and being being a southeast corner of lands now or formerly owned by Vickie L. Eichof as recorded in Official Record Volume 1583, Page 575;
- North 00°46'34" East, 800.50 feet with the east line of said Eichof lands to a rebar with cap stamped "Vance 6553" found in the south line of the Pennsylvania Lines, LLC Railroad as recorded in Official Record Volume 801, Page 593;
- 5. North 70°36'31" East, 698.69 feet with the south line of said Pennsylvania Lines, LLC lands to a 5/8" rebar with cap stamped "Weigler 7747" set in the east line of said quarter;
- South 00°29'45" West, 1340.82 feet with the east line of said quarter to the point of beginning, containing 17.1269 acres, of which 15.5076 acres are in Permanent Parcel No. 0372807013000 and 1.6193 acre is in Permanent Parcel No. 0372807013002, being subject to all legal easements, restrictions and rights-of-way now on record.

Bearings are based on an assumed meridian, and are used to express angles only.
