COMMENCING at the intersection of the South line of the Southwest quarter of Section 32 with the centerline of State Highway 61 (an existing iron pin being South 89 deg. 47 min. 57 sec. West and 31.75 feet from this point);

Thence running North 18 deg. 54 min. 43 sec. East along the centerline of State Highway 61 for 249.39 feet to an existing railroad spike being the beginning of a 04 deg. 24 min. 31 sec. Degree Curve to the Left having a Radius of 1299.63 feet;

Thence running Northeasterly along said Curve and centerline for a Length of 155.00 feet (Chord of North 15 deg. 29 min. 43 sec. East, 154.91 feet, Delta 06 deg. 50 min. 00 sec.) to the **PLACE OF BEGINNING** (referenced by an existing iron pin South 78 deg. 49 min. 31 sec. East and 30.00 feet;

Thence continuing Northeasterly along said Curve and centerline for a Length of 20.00 feet (Chord of North 11 deg. 38 min. 16 sec. East, 20.00 feet, Delta 00 deg. 52 min. 54 sec.);

Thence turning and running South 78 deg. 49 min. 31 sec. East (passing a 5/8 inch rebar set at 30.00 feet) for a total distance of 501.58 feet to a 5/8 inch rebar set on the Westerly right-of-way of the Ashland Railway Inc.;

Thence turning and running South 27 deg. 52 min. 05 sec. East along said right-of-way for 25.75 feet to an existing iron pin;

Thence turning and running North 78 deg. 49 min. 31 sec. West (passing an existing iron pin at 487.96 feet) for a total distance of 517.96 feet to the place of beginning.
