DESCRIPTION OF 0.897 ACRE PARCEL ZAC ARNOLD

Situated in the State of Ohio, County of Richland, Village of Plymouth, lying in part of Outlot 42 and part of Lot 74, of an original tracts conveyed to Z. Arnold by deed of record in Official Record Volume 2772, Page 172 (all references are to the records of the Recorder's Office, Richland County, Ohio) and being more particularly described as follows:

COMMENCING at the Northeast corner of said Lot 74 on the Southerly right-of-way of Trux Street (60' R/W), referenced by an iron pin found, North 31°58'31" East, a distance of 0.75 feet;

thence North 55°34'26" West, with the Southerly right-of-way of said Trux Street, a distance of 161.22 feet to the Northwest corner of a tract conveyed to J. Cooley by deed of record in Official Record Volume 2905, Page 676, said point being the POINT OF BEGINNING for the tract herein described, referenced by an iron pipe found, North 02°09'43" West, a distance of 1.67 feet:

thence South 02°09'43" East, with the West line of said tract conveyed to J. Cooley, a distance of 227.75 feet to the North line of the A.C. & Y. Railroad, passing an iron pipe found, a distance of 223.83 feet;

thence with the North line of said A.C. & Y. Railroad, with a curve turning to the right with an arc length of 242.20 feet, with a delta angle of 7°45'36", with a radius of 1788.25 feet, with a chord bearing of South 69°51'05" West, and a chord length of 242.01 feet to the Southeast corner of a tract conveyed to Plymouth Church of God, Inc. by Official Record Volume 911, Page 767, referenced by a bolt found, North 25°30'06" East, a distance of 4.12 feet;

thence North 25°30'06" East, with the East line of said Plymouth Church of God, Inc. tract, a distance of 384.74 feet to the Northeast corner of said Plymouth Church of God, Inc. tract and the Southerly right-of-way of said Trux Street, passing an iron pipe found at a distance of 383.99 feet:

thence South 55°34'26" East, with the Southerly right-of-way of said Trux Street, a distance of 64.21 feet to the POINT OF BEGINNING, containing 0.897 total acres of land, more or less;

Subject, however, to all legal rights-of-ways and/or easements of record.

The bearings herein are based on Richland County Engineer Survey Y-65.
