LEGAL DESCRIPTION

January 31, 2022

Situated in the Township of Bloominggrove, County of Richland, State of Ohio, and being a part of the Southwest Quarter of Section 19, Township 23-North, Range 18-West and being all of the lands conveyed to Lucinda M. Sauder by official record volume 1994, page 589 of the Richland County Recorder's records and being more particularly described as follows:

Commencing at a Magnail spike found and accepted as marking the northwest corner of said Quarter, said Magnail also being on the intersection of the centerline of Kaster Road-(T.H. 214)(30' R/W) and the centerline of Ranson Road-(T.H. 422)(60' R/W);

Thence, North 89 degrees 11 minutes 47 seconds East, 1304.82 feet along the north line of said Quarter, said centerline of Kaster Road to an iron pin found in a northeast corner of a parcel conveyed to Kenneth B. Jr. and Charlene A. Burrer by official record volume 209, page 831, said iron pin also being the **Place of Beginning** of the parcel described herein;

Thence, the following FOUR courses:

- 1. North 89 degrees 11 minutes 47 seconds East, 625.14 feet continuing along said north line and said centerline of Kaster Road to an iron pin set in the northwest corner of a parcel conveyed to Cory D. and Melissa A. Myers by official record volume 429, page 969;
- 2. South 01 degree 28 minutes 27 seconds East, 394.13 feet along the west line of said Myers parcel to a point in the southwest corner thereof, the north line of a parcel conveyed to Kenneth B. Jr. and Charlene A. Burrer by official record volume 209, page 829, referenced by an iron pin found South 01 degree 28 minutes 27 seconds East, 0.89 feet, and passing through an iron pin found for reference at 24.53 feet;
- 3. **South 89 degrees 12 minutes 00 seconds West, 624.51 feet** along said north line of Burrer parcel to an iron pin set in the northwest corner thereof, said iron pin also being on the east line of aforementioned Burrer parcel (ORV. 209, Pg. 831);

4. **North 01 degree 33 minutes 59 seconds West, 394.10 feet** along said east line of Burrer parcel to the **Place of Beginning** and containing 5.6527 acres, more or less, and subject to all legal highways, easements, leases, and use restrictions of record.

Bearings are to an assumed meridian and are used to express angles only.

Iron pins set are 5/8" rebar with plastic cap stamped "Ramsey S-8396"
