



DESCRIPTION PART OF THE NORTHEAST QUARTER, SECTION SEVENTEEN (17) TOWNSHIP TWENTY-ONE (21), RANGE NINETEEN (19) SPRINGFIELD TOWNSHIP, RICHLAND COUNTY, OHIO PARCEL 1 0.4898 ACRE

DESCRIPTION: Being part of the Northeast Quarter of Section Seventeen (17), Township Twenty-One (21), Range Nineteen (19), Springfield Township, Richland County, Ohio, and being more particularly described as follows:

Commencing for the same at a 3" survey spike set at the intersection of the south line of the Northeast Quarter of Section 17 and the centerline of State Route 314 (50 feet in width), said point also being on the east line of a 0.52 acre parcel described in Official Record Volume 2969, Page 812; thence N15°48'09"E, along the centerline of State Route 314 and the east line of said 0.52 acre parcel, a distance of 56.80 feet to the northeast corner of said 0.52 acre parcel which is to the real point of beginning for the parcel herein described, said point being referenced by an iron pipe found N74°11'51"W, 25.01 feet;

- 1) thence N74°11'51"W, along the north line of said 0.52 acre parcel and passing for reference an iron pipe found at 25.01 feet, a total distance of 145.00 feet to an iron pin set;
- 2) thence on a curve to the left having a radius of 530.95 feet, a delta of 08°08'00", and an arc length of 75.37 feet (chord bearing N76°29'38"W, 75.31 feet), continuing along the north line of said 0.52 acre parcel, to an iron pipe found at the northwest corner of said 0.52 acre parcel, said point also being at the northeast corner of a parcel in the name of Turner described in Deed Volume 629, Page 770;
- 3) thence N87°19'02"W, along the north line of said Turner parcel, a distance of 58.52 feet to an iron pin set;
- 4) thence N88°25'05"W, continuing along the north line of said Turner parcel, a distance of 67.62 feet to an iron pipe found at the northwest corner of said Turner parcel;
- 5) thence N01°34'55"E, a distance of 60.00 feet to an iron pin set;
- 6) thence S88°25'05"E, a distance of 141.46 feet to an iron pin set;
- 7) thence S74°11'51"E, passing for reference an iron pin set at 195.40 feet, a total distance of 220.40 feet to the centerline of State Route 314;
- 8) thence S15°48'09"W, along the centerline of State Route 314, a distance of 60.00 feet to the real point of beginning,

and containing 0.4898 acre, more or less, but subject to all legal easements and public rights-of-way now on record. All iron pin set are 5/8" diameter, 30" long rebar with caps stamped "Krocka & Assoc". Bearings are assumed.

Grantees, their heirs and assigns do hereby covenant and agree that the parcel of land described in this instrument or any portion thereof does not constitute a principal building site and will not be conveyed by said grantees, their heirs, and assigns independent and separate from any adjoining or contiguous parcel fronting on a public highway or street.
