Commencing at an iron pin found in the southwest corner of said Southeast Quarter;

Thence N 00° 09' 36" W, 526.00 feet along the west line of said Southeast Quarter to an iron pin found in the northwest corner of a parcel of land conveyed to Gerald L. and Beverly A. Smith by deed volume 810, page 521, said iron pin also being in the southwest corner of a parcel of land conveyed to Wilburn and Mona L. Adkins by official records volume 2388, page 806;

Thence N 89° 28' 06" E, 586.21 feet along the north line of said land of Gerald L. and Beverly A. Smith, also being along the south line of said land of Wilburn and Mona L. Adkins to an iron pin found in the southeast corner of said land of Wilburn and Mona L. Adkins, said iron pin also being in the southwest corner of a parcel of land conveyed to Lundquist Vacation Rentals LLC by official records volume 2495, page 460;

Thence N 89° 32' 24" E, 258.00 feet and continuing along said north line of said land of Gerald L. and Beverly A. Smith, also being along the south line of said land of Lundquist Vacation Rentals LLC to a railroad spike found in the southeast corner of said land of Lundquist Vacation Rentals LLC, said railroad spike also being in the centerline of Garber Road (T.H. 115)(60') and passing through an iron pin found at 233.09 feet;

Thence N 03° 19' 40" E, 292.06 feet along said centerline of Garber Road (T.H. 115)(60') to a point being a northwesterly corner of a parcel of land conveyed to Conrad D. and Lois A. Miller by official records volume 2958, page 80, said point being referenced by an iron pin found N 80° 17' 30" E, 23.60 feet from said point and being the **true place of beginning**;

Thence with the following FIVE courses:

- 1) N 03° 19' 40" E, 68.52 feet and continuing along said centerline of Garber Road (T.H. 115)(60') to a railroad spike found;
- 2) N 00° 06' 14" E, 295.26 feet and continuing along said centerline of Garber Road (T.H. 115)(60') to a point, said point being referenced by an iron pin set N 64° 00' 29" E, 27.41 feet from said point;
- 3) N 00° 03' 32" W, 7.79 feet and continuing along said centerline of Garber Road (T.H. 115)(60') to a point, said being referenced by an iron pin set N 80° 17' 30" E, 25.00 feet from said point;
- 4) N 80° 17' 30" E, 608.48 feet to an iron pin set in a west line of said land of Conrad D. and Lois A. Miller and passing through previously referenced iron pin set at 25.00 feet;
- 5) S 03° 55' 42" W, 375.98 feet along said west line of said land of Conrad D. and Lois A. Miller to an iron pin found in an interior corner of said land;
- 6) S 80° 17' 30" W, 586.92 feet along a northerly line of said land of Conrad D. and Lois A. Miller to the true place of beginning, passing through previously referenced iron pin found at 563.32 feet and containing 5.000 acres, more or less, and subject to all legal highways and easements of record.

Thence N 89° 32′ 24″ E, 258.00 feet and continuing along said north line of said land of Gerald L. and Beverly A. Smith, also being along the south line of said land of Lundquist Vacation Rentals LLC to a railroad spike found in the southeast corner of said land of Lundquist Vacation Rentals LLC, said railroad spike also being in the centerline of Garber Road (T.H. 115)(60′) and passing through an iron pin found at 233.09 feet;

Thence N 03° 19' 40" E, 360.58 feet along said centerline of Garber Road (T.H. 115)(60') to a railroad spike found;

Thence N 00° 06′ 14″ E, 295.26 feet and continuing along said centerline of Garber Road (T.H. 115)(60′) to a point, said point being referenced by an iron pin set N 64° 00′ 29″ E, 27.41 feet from said point;

Thence N 00° 03' 32" W, 7.79 feet and continuing along said centerline of Garber Road (T.H. 115)(60') to a point, said point being referenced by an iron pin set N 80° 17' 30" E, 25.00 feet from said point; and being the **true place of beginning**;

Thence with the following **FIVE** courses:

- 1) N 00° 03' 32" W, 592.21 feet and continuing along said centerline of Garber Road (T.H. 115)(60') to a mag nail found, said mag nail being in the southerly corner of a parcel of land conveyed to Richard S. Spayde by official records volume 675, page 323;

Wade by official records volume 2961, page 505 to an iron pin found in a northwest corner of a parcel of land conveyed to Conrad D. and Lois A. Miller by official records volume 2958, page 80;
- 4) S 03° 55' 42" W, 692.71 feet alone the west line of said land of Conrad D. and Lois A. Miller to an iron pin set;
- 5) S 80° 17' 30" W, 608.48 feet to the true place of beginning, passing through previously referenced iron pin set at 583.48 feet and containing 10.576 acres, more or less, and subject to all legal highways and easements of record.
