
PLAT OF BOUNDARY SURVEY FOR

DESCRIPTION 4.0605 ACRES

Situated in the State of Ohio, County of Richland, Township of Sharon, City of Shelby, being part of the Northeast Quarter of Section Five (5), Township Twenty-two (22), Range Nineteen (19) and being a 4.3 acre parcel now or formerly owned by IFM Properties as recorded in Official Record Volume 2732, Page 452, and being more particularly described as follows;

BEGINNING at a rebar with cap stamped "C Kerg RLS 7152" found marking the intersection of the west right-of-way line of CSX railroad and the east right-of-way line of Cleveland Street (40 feet in width);

Thence with the following Four (4) courses;

- 1. North 03°53'43" East, 737.69 feet with the east right-of-way line of said Cleveland Street to a 5/8" rebar with cap stamped "C Kerg RLS 7152" found, said rebar also marking the southwest corner of lands now or formerly owned by RPF Limited Partnership as recorded in Official Record Volume 406, Page 51;
- 2. South 89°54'52" East, 414.36 feet with the south line of said RFP Limited Partnership lands to the centerline of CSX Railroad, passing through a rebar with cap stamped "C Kerg RLS 7152" found in the west right-of-way line of CSX Railroad at 357.17 feet;
- 3. South 28°56'30" West, 976.39 feet with the centerline of CSX Railroad to a point being referenced by a rebar with cap stamped "C Kerg RLS.7152" found North 03°53'43" East, 118.12 feet;
- 4. North 03°53'43" East, 118.12 feet, to the point of beginning, containing 4.0605 acres, being subject to all legal easements, restrictions and rights-of-way now on record.

Bearings are based on survey file A-367 of the Richland County Tax Map Records, and are used to express angles only.
