



## **Legal Description**

**Situated** in the City of Mansfield, Township of Madison, County of Richland, State of Ohio, and being a part of the Northwest Quarter of Section 32 and the Southwest Quarter of Section 32, Township 21-North, Range 18-West, and being a portion of land conveyed to Antrim Properties LLC, by official record volume 1295, page 751 of the Richland County Recorder's records and being more particularly described as follows:

**Commencing** at a point in a monument box found at the southwest corner of the Northwest Quarter of Section 32, also being Trimble Road (C.R. 281 - R/W Varies) centerline of right-of-way, said point being referenced by a 1" iron pin found North 78 degrees 44 minutes 21 second East, 0.14 feet, in said monument box;

Thence North 89 degrees 10 minutes 43 seconds East, 55.00 feet along the south line of the Northwest Quarter of Section 32 to a point on the grantor's west property line, also being the east right-of-way line of Trimble Road (C.R. 281), and being the Place of Beginning of the parcel herein described;

Thence, the following **TEN** courses:

- 1. **North 00 degrees 59 minutes 00 seconds West, 64.14 feet** along the grantor's west property line, also being the east right-of-way line of Trimble Road (C.R. 281), to an iron pin set;
- 2. North 89 degrees 01 minute 02 seconds East, 28.06 feet to an iron pin set marking a point of curvature;
- 3. Southeasterly along a curve to the right having a radius of 94.00 feet, a delta angle of 89 degrees 53 minutes 53 seconds, an arc length of 147.49 feet, a chord bearing of South 46 degrees 02 minutes 01 second East, and a chord length of 132.82 feet to an iron pin set marking a point of tangency;
- 4. South 01 degree 05 minutes 05 seconds East, 28.07 feet to an iron pin set marking a point of curvature;

- 5. Southwesterly along a curve to the right having a radius of 94.00 feet, a delta angle of 90 degrees 00 minutes 00 seconds, an arc length of 147.65 feet, a chord bearing of South 43 degrees 54 minutes 55 seconds West, and a chord length of 132.94 feet to an iron pin set marking a point of tangency;
- 6. **South 88 degrees 54 minutes 55 seconds West, 26.00 feet** to an iron pin set on the grantor's west property line, also being the east right-of-way line of Trimble Road (C.R. 281);
- 7. **North 01 degree 05 minutes 05 seconds West, 77.13 feet** along said grantor's west property line, also being the east right-of-way line of Trimble Road (C.R. 281), to a point;
- 8. **North 18 degrees 42 minutes 51 seconds East, 26.57 feet** along said grantor's west property line, also being the east right-of-way line of Trimble Road (C.R. 281), to a point;
- 9. **North 01 degree 05 minutes 05 seconds West, 25.00 feet** along said grantor's west property line, also being the east right-of-way line of Trimble Road (C.R. 281), to a point;
- 10. North 24 degrees 57 minutes 47 seconds West, 27.18 feet along said grantor's west property line, also being the east right-of-way line of Trimble Road (C.R. 281), to the **Principal Place of Beginning** containing 0.5013 of an acre more or less.

The above-described area is part of the following Richland County Auditors permanent parcel numbers:

0.1377 of an acre is part of permanent parcel number 027-07-221-94-003 in the Northwest Quarter of Section 32.

0.3636 of an acre is part of permanent parcel number 027-07-221-93-001 in the Southwest Quarter of Section 32.

Bearings are based on grid north of the Ohio State Plan Coordinate System, NAD83(2011), North Zone originating on the ODOT VRS Network and are for the purposes of determining direction variations only.

Iron pins set are 5/8-inch diameter reinforcing rods with a plastic cap stamped "McCartney-7921".
