DESCRIPTION

PART OF THE SOUTHWEST AND SOUTHEAST QUARTERS OF SECTION SEVENTEEN (17), TOWNSHIP 22-N, RANGE 19-W, SHARON TOWNSHIP, RICHLAND COUNTY, OHIO

DESCRIPTION: Being part of the Southwest and Southeast Quarters of Section 17, Township 22-N, Range 19-W, Sharon Township, Richland County, Ohio and being more particularly described as follows;

Commencing at an iron pin set at the Southeast Corner of the Southwest Quarter of Section 17; thence N89°29′02″E a distance of 12.20 feet along the South line of the Southeast Quarter of said Section 17 to an iron pin found in the centerline of Stiving Road (T.R. 168 – 60 feet in width); thence N29°25′00″W a distance of 94.04 feet on the centerline of said Stiving Road to a survey marker nail set, which nail is the real Point of Beginning of the parcel herein described, referenced by an iron pin set N89°12′00″E a distance of 25.00 feet there from;

- 1.) Thence N29°25'00"W a distance of 236.22 feet along said centerline of Stiving Road to a survey marker nail found;
- 2.) Thence N90°00′00″E a distance of 348.74 feet passing an iron pin found at 25.00 feet, and at 250.30 feet to an iron pipe found;
- 3.) Thence S00°52'00"W a distance of 202.58 feet to an iron pin set;
- Thence S89°12'00"W a distance of 229.68 feet passing the iron pin set 204.68 feet; to the survey marker nail set at the real Point of Beginning,

and containing **1.357** Acres more or less, of which 0.434 acres are in the Southwest Quarter of said Section 17, and 0.923 acres are in the Southeast Quarter of said Section 17, but subject to all legal easements and public right-of-way now on record. All iron pins set are 5/8" rods and have caps stamped "LUTZ 6756".
