## **LEGAL DESCRIPTION**

## PARCEL 1

June 18, 2024

Situated in the Township of Washington, County of Richland, State of Ohio, and being a part of the Southwest Quarter of Section 20, Township 20-North, Range 18-West and being a portion of the lands conveyed to Denise E. Rebman, by official record volume 2302, page 801 of the Richland County Recorder's records and being more particularly described as follows:

Commencing at a Magnail spike found and accepted as marking the southwest corner of said Quarter and being on the centerline of Vanderbilt Road-(T.R. 328)(60' R/W);

Thence, North 89 degrees 01 minute 40 seconds East, 424.97 feet along the south line of said Quarter, said centerline of Vanderbilt Road to a point being the southeast corner of a parcel conveyed to Klodian and Anila Prifti by official record volume 1942, page 732;

Thence, North 00 degrees 25 minutes 10 seconds West, 328.41 feet along the east line of said Pfriti parcel to an iron pin found in the northeast corner thereof, passing through an iron pin found for reference at 30.52 feet and being the **Place of Beginning** of the parcel herein described;

Thence, the following **FOUR** courses:

- 1. South 88 degrees 59 minutes 26 seconds West, 199.54 feet along the north line of said Prifti parcel to an iron pin found in the northwest corner thereof, also being on the east line of a parcel conveyed to Floyd L. Perry, Jr and Linda L. Perry by official record volume 16, page 899;
- 2. North 00 degrees 20 minutes 50 seconds West, 49.56 feet along said east line of Perry parcel to an iron pin set;
- 3. North 88 degrees 50 minutes 29 seconds East, 199.48 feet traversing the aforementioned Rebman parcel to an iron pin set;
- 4. South 00 degrees 25 minutes 10 seconds East, 50.08 feet traversing said Rebman parcel to the Place of Beginning, containing 0.228 of an acre (9938.00 sf), more or less, and subject to all legal highways, easements, leases, and use restrictions of record.

Bearings are to an assumed meridian and are used to express angles only.

Iron pins set are 5/8" rebar with plastic cap stamped "Ramsey-S-8396"

Grantees, their heirs and assigns do hereby covenant and agree that the parcel of land described in this instrument does not constitute a principal building site under applicable zoning and will not be conveyed by said grantees, heirs and assigns independent and separate from any adjoining or contiguous parcel fronting on a public highway or street.
