Situated in the State of Ohio, County of Richland, Township of Plymouth, lying in the Northwest Quarter and Southwest Quarter of Section Eleven (11), Township Twenty Two (22), Range Twenty (20), of an original tract conveyed to L.J. BeVier by deed of record in Official Record Volume 2668, Page 291 (all references are to the records of the Recorder's Office, Richland County, Ohio) and being more particularly described as follows:

BEGINNING at a railroad spike set over a railroad spike found at the Northwest corner of the Northwest Quarter of said Section 11 and the intersection of West Road (T.H. 65) and Lauden Road (T.H, 10);

thence North 89°59'41" East, with the North line of the Northwest Quarter of said Section 11 and the centerline of said West Road, a distance of 1323.43 feet to a railroad spike found at the Northwest corner of a 46.2579 acre tract conveyed to S.A. Schroeder by deed of record in Official Record Volume 2085, Page 46, referenced by a capped "Village Engineering" iron pin found, South 01°17'37" East, a distance of 30.00 feet;

thence South 01°17'37" East, with the West line of said 46.2579 acre tract, a distance of 1649.32 feet to an iron pin set at the Southwest corner of said 46.2579 and the Northwest corner of a 49.41 acre tract conveyed to Niese Acres LTD by deed of record in Official Record Volume 807, Page 586;
