Beginning for the same at an iron pin found and accepted as marking the northwest corner of Lot #18239, Thence, South 89 degrees 58 minutes 01 second East with the north line of said lot 66.67 feet to an iron pin set;

Thence, South 00 degrees 19 minutes 15 seconds East 406.98 feet to an iron pin set on the south line of said lot, the same as being the northerly right of way of Empire Road (60' R/W);

Thence, South 89 degrees 53 minutes 42 seconds West with said south lot line and the north right of way of said road 66.06 feet to an iron pin set marking the southwest corner of said lot;

Thence, North 00 degrees 24 minutes 21 seconds West with the west line of said lot 407.14 feet to the place of beginning, containing 27,014 square feet, according to a survey by Chad F. Craig P.S. #8195 for Seiler & Craig Surveying, Inc. on June 17, 2024, but subject to all easements, right of ways and highways of record.

Situated in the City of Mansfield, County of Richland, State of Ohio and being known as Part Lot #18238 and Part Lot #18239 of the consecutively numbered lots in said city, and being more particularly described as follows:

Beginning for the same at an iron pin found and accepted as marking the southeast corner of Lot #18239, the same as being the southwest corner of Lot #18238 and being a point on the northerly right of way of Empire Road (60' R/W), Thence, South 89 degrees 53 minutes 42 seconds West with the south line of Lot #18239 and with said northerly right of way 33.74 feet to an iron pin set;

Thence, North 00 degrees 19 minutes 15 seconds West 406.98 feet to an iron pin set on the north line of Lot #18239;

Thence, South 89 degrees 58 minutes 01 second East with the north line of said lot and the easterly prolongation thereof 66.67 feet to an iron pin set on the north line of Lot #18238;

Thence, South 00 degrees 14 minutes 10 seconds East 406.82 feet to an iron pin set on the south line of Lot #18238 and the north right of way of said road;
