

SURVEY DESCRIPTION PARCEL "A"

PART OF THE SE QUARTER OF SECTION 18 JEFFERSON TOWNSHIP RICHLAND COUNTY, OHIO

Situated in the Township of Jefferson, County of Richland, State of Ohio and being a part of the Southeast quarter of Section 18 of Township 19 North, Range 18 West, and being more particularly described as follows:

Commencing at a railroad spike found and accepted as marking the southeast corner of the southeast quarter of Section 18 and marking the intersection of the centerline of Renie Road (T.H. 117) with the centerline of Honey Creek Road (T.H. 402), Thence, South 88 degrees 55 minutes 43 seconds West with the south line of said quarter section and the centerline of Honey Creek Road 261.61 feet to a point marking the southwest corner of a parcel currently owned by G. & O. Fry (D.V. 784, P. 77) said point being referenced by an iron pin found on a bearing of North 00 degrees 48 minutes 15 seconds West and at a distance of 29.69 feet, said point being the place of beginning of the parcel herein described;

Thence, continuing South 88 degrees 55 minutes 43 seconds West with the south line of said quarter section and said centerline 236.56 feet to a point marking the southeast corner of a parcel currently owned by P.L. Klinetop (O.R.V. 1774, P. 850) and being referenced by an iron pin found on a bearing of North 00 degrees 45 minutes 38 seconds West and at a distance of 30.06 feet;

Thence, North 00 degrees 45 minutes 38 seconds West with the east line of said Klinetop parcel passing through said iron pin found, a total distance of 447.24 feet to an iron pin found on the northeast corner of said parcel;

Thence, South 88 degrees 53 minutes 09 seconds West with the north line of said parcel and the westerly prolongation thereof 474.41 feet to an iron pin found on the northwest corner of a parcel currently owned by R. & J. Joan (O.R.V. 2928, P. 487);

Thence, South 00 degrees 47 minutes 59 seconds East with the west line of said Joan parcel passing through an iron pin found at a distance of 416.89 feet, a total distance of 446.88 feet to a point on the south line of said quarter section and in said centerline;

Thence, South 88 degrees 55 minutes 43 seconds West with the south line of said quarter section and with said centerline 591.81 feet to a point marking the southeast corner of a parcel currently owned by G. and O. Fry (O.R.V. 1693, P. 824) and being referenced by an iron pin found on a bearing of North 00 degrees 25 minutes 20 seconds West and at a distance of 30.18 feet;

Thence, North 00 degrees 25 minutes 20 seconds West with the east line of said Fry parcel passing through said iron pin found, a total distance of 136.17 feet to an iron pipe found on the northeast corner of said parcel;

Thence, North 88 degrees 27 minutes 49 seconds West with the north line of said parcel 848.96 feet to an iron pipe found on the east line of a parcel currently owned by K.L. Kindt (O.R.V. 3015, P. 34);

Thence, North 00 degrees 22 minutes 37 seconds West with the east line of said Kindt parcel 547.14 feet to an iron pin found on the northeast corner of said parcel;

Thence, North 89 degrees 58 minutes 35 seconds West with the north line of said parcel 272.24 feet to an iron pin found on the west line of said quarter section;

Thence, North 00 degrees 21 minutes 49 seconds West with the west line of said quarter section 107.81 feet to an iron pin set;

Thence, South 85 degrees 00 minutes 39 seconds East 730.98 feet to an iron pin set;

Thence, North 03 degrees 06 minutes 22 seconds West 505.51 feet to an iron pin set;

Thence, North 11 degrees 40 minutes 35 seconds East 240.01 feet to an iron pin set;

Thence, North 89 degrees 45 minutes 40 seconds East 231.77 feet to an iron pin set;

Thence, North 00 degrees 04 minutes 47 seconds East 237.86 feet to an iron pin set;

Thence, North 88 degrees 05 minutes 01 second East 813.85 feet to an iron pin set;

Thence, South 00 degrees 17 minutes 36 seconds West 262.64 feet to an iron pin set;

Thence, South 87 degrees 54 minutes 20 seconds East passing through an iron pin set for reference at a distance of 847.48 feet, a total distance of 877.48 feet to a point on the east line of said quarter section and in the centerline of Renie Road:

Thence, South 00 degrees 46 minutes 56 seconds East with the east line of said quarter section and with said centerline 987.46 feet to a point marking the northeast corner of a parcel currently owned by G. & O. Fry (D.V. 803, P. 426) and being referenced by an iron pin found a bearing of South 89 degrees 24 minutes 52 seconds West and at a distance of 26.41 feet;
